**Change of Premises of the Institution**


In terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Madanlal Memorial College of Education, Plot No-1241, Vill-Sinhed, P.O. Sinhet, Tehsil/Taluka-Polba Dadpur, Town/City- Chinsurah, Dist-Hooghly, West Bengal-712305 of two year duration with an intake of 50 student vide ERC order No. ERC-268. 6.16/ ERCAPP298 8/B.Ed/2019 /59580 dated 28.09.2019 and D. El.Ed course with an intake of 50 student vide ERC order No. 268.6.17/ERCAPP2997 /B.Ed/2019 /59579 dated 28.02.2019 respectively as per NCTE Regulation, 2014.

2. **AND WHEREAS**, the representation of the institution dated 16.08.2019 which is received on dated 27.11.2019 for shifting of institution from Plot No-1241, Vill-Sinhed, P.O. Sinhet, Tehsil/Taluka-Polba Dadpur, Town/City-Chinsurah, Dist-Hooghly, West Bengal-712305 to Vill-Paschim Narayanpur, P.O.- Tarakeshwar, P.S.- Dhaniakhali, Dist-Hooghly, West Bengal-712410 for running one unit of B.Ed. programme and one unit of D.El.Ed. programme was placed before ERC in its 309<sup>th</sup> (Virtual) meeting (part-2) held from 14.09.2022 to 15.09.2022 and the committee decided that:-

- The State Government of West Bengal vide its reply dated 29.04.2022 received in ERC office on 17.05.2022 verified the authenticity of land documents submitted by the Institution. 
