**ORDER**

**WHEREAS**, in terms of Section 14(1) of the NCTE Act, 1993, **Namrup College of Teacher's Education, P.O.Parbatpur, Dist.Dibrugarh, Assam - 786623 (AS-S/N-25/96)** applied for grant of recognition to for **B.Ed. programme on 30.12.1996.**

2. **AND WHEREAS**, the institution viz. **Namrup College of Teacher's Education, P.O.-Parbatpur, Dist.Dibrugarh, Assam - 786623** was granted recognition for B.Ed. Course of one year duration with an intake of 50 vide ERC Order No. ERC/7-17/2001/528(6) dated 12/13.03.2001, followed by revised recognition for B.Ed. course of two years duration with an intake of 50 students (one basic unit) from the academic session 2015-2016 vide ERC Order No.F.ERC/NCTE/AS-S/N-25/96/B.Ed.(Revised Order)/2015/31775 dt.20.05.2015, as per NCTE Regulations, 2014.


3. **AND WHEREAS**, the ERC in its 266<sup>th</sup> meeting held on 31<sup>st</sup> January, 2019 considered the matter of compliance report in light of NCTE Regulations, 2014 submitted by the institution and as decided by ERC, show cause notice under Section 17(1) issued to the institution vide letter No.F.3-3/Regulation/NCTE/ERC/2016-2019/59328 dated 14.02.2019 with direction to comply following within 21 days from the date of issue of the letter:

- (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the concerned competent Govt. Engineer/Authority
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit

4. **AND WHEREAS**, the ERC in its 271<sup>st</sup> meeting held on 24<sup>th</sup>-25<sup>th</sup> April, 2019 considered reply in response to show cause notice and as decided by ERC, second show cause notice under Section 17(1) issued to the institution vide letter No.F.ER-271.14.49/(AS-S/N-25/96)/B.Ed./2019/60362 dated 14.05.2019 with direction to comply following within 21 days from the date of issue of the letter:

- (i) The submitted building plan is in small font and not legible. A clear copy of blue print building plan duly approved by competent Govt. Engineer is required to be submitted.
- (ii) Building completion certificate in accordance with NCTE prescribed proforma duly signed by competent Govt. Engineer is not submitted.
- (iii) Faculty list approved by the concerned affiliating body in accordance with NCTE prescribed proforma is not submitted.
- (iv) Website not maintained and updated.

5. **AND WHEREAS**, the ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2019 considered reply in response to show cause notice and as decided by ERC recognition granted to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021 vide Order F.No.ER-274.14.33/AS-S/N-25/96/B.Ed./2019/61400 dated 26.08.2019 on the following grounds:

- (i) Faculty list comprises 1+5 instead of 1+7 as per NCTE Regulations, 2014.
- (ii) Principal does not possess Ph.D. qualification.
- (iii) Building completion certificate is not signed by Govt. Engineer.
- (iv) Part-time/guest faculty are not accepted.

6. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's withdrawal order dated 26.08.2019. The Appellate Authority vide its Order No.89-281/E-171746/2020 Appeal/3<sup>rd</sup> Mtg.-2021/20<sup>th</sup> January, 2021/97391 dated 11.02.2021 concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal, to be sent to them by the appellant, and take further necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC, the documents submitted in appeal, within 15 days of receipt of orders on the appeal.

7. **AND WHEREAS**, the institution had submitted representation dt. 13.02.2021 received in this office on 23.02.2021. The ERC in its 290<sup>th</sup> (part-I) meeting held on 3<sup>rd</sup> March, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 11.02.2021 and accordingly issued Show Cause notice to the institution vide letter F.No.ERC/290.22/AS-S/N-25/96/B.Ed./2021/63823 dated 16.03.2021 to comply the following within 30 days from the date of issue of show cause notice:

- (i) Newly appointed Principal viz. Dr. Preeti Rekha Goswami does not possess requisite qualification as required under NCTE Regulation, 2014.
- (ii) Lecturer in Social Science viz. Prakriti Bora reflected at sl.no.7 of list of approved faculty newly appointed on 14.10.2019. She is not having NET/Ph.D. qualification as per NCTE Regulations, 2014 and amended Regulations dated 09.06.2017 and her educational qualification testimonials not attached.
- (iii) Lecturer in Physical Education, Fine Arts/Music is not appointed as required under NCTE Regulations, 2014.
- (iv) The institutional website (www.ctenamrup.com) is not maintained and updated as per Clause 7(14)(i) of NCTE NCTE Regulations, 2014. Relevant documents including approved faculty list are not uploaded on the website.

8. **AND WHEREAS**, the ERC in its 300<sup>th</sup> ERC (Virtual) Meeting held on 28<sup>th</sup> December, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, representations from the institution in response to final show cause notice and made following observations:

"The institution is still deficient on the following in light of NCTE Regulations, 2014:

- (i) Consolidated Faculty list as per NCTE Norms and Regulations for B.Ed. course is not approved by Registrar of the Affiliating University.
- (ii) Original affidavit on Rs.100/- non-judicial stamp paper by the management regarding selection/appointment of faculty is not in the NCTE prescribed proforma.
- (iii) Original affidavit on Rs.10/- non-judicial stamp paper in respect of newly appointed faculty in prescribed format not submitted.
- (iv) The institutional website (www.ctenamrup.com) is not maintained and updated as per Clause 7(14)(i) of NCTE Regulations, 2014. Relevant documents including approved faculty list are not uploaded on the institutional website.

Hence, Final show cause notice under section 14(3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice."

Accordingly, final show cause notice issued to the institution vide letter F.No.ERC-300.6/AS-S/N-25/96/B.Ed./2021/64848 dated 31.12.2021.

9. **AND WHEREAS**, the ERC in its 302<sup>nd</sup> (Virtual) Meeting held on 28<sup>th</sup> February and 01<sup>st</sup> March, 2022 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, appeal remand back order dated 11.02.2021, representation dated 04.01.2022 received on 12.01.2022 from the institution in reference to grounds of show cause notice dated 31.12.2021 and the Committee made following observations:-

"The institution is still deficient on the following in light of NCTE Regulations 2014:

1. Previously appointed unqualified Principal viz. Dr. Preeti Rekha Goswami has been replaced by (Dr. Arindam Bankura) who has been newly appointed on 23.09.2021. His experience certificate, Ph.D./NET Certificate, educational qualification/testimonials are attached with the reply of SCN are not self-attested by the individual or by the management with seal. His date of birth(15.11.1970) mentioned in the approved faculty list differs with date of birth(15.11.1979) mentioned by the individual in his affidavit on Rs.10/-non-judicial stamp paper.
2. Previously appointed unqualified faculty i.e. Lecturer in Social Science viz. Prakriti Bora has been replaced by (Dr. Krishanu Ganguly) who has been newly appointed on 23.09.2021. His Ph.D./NET Certificate not attached, educational qualification/testimonials attached with the reply of SCN are not self-attested by the individual or by the management with seal. His date of birth is not mentioned in the approved faculty list, whereas in affidavit on Rs.10/-non-judicial stamp paper, date of birth mentioned as 05.02.1988.Name of the said faculty have been differently mentioned in the three documents i.e.
  - (a) In original notarized Affidavit on Rs.100/- non-judicial stamp paper by the management, name is Dr. Krishanu Ganguly.
  - (b) In original notarized Affidavit on Rs.10/- non-judicial stamp paper by the individual faculty, name is Dr. Krishanu Ganguly.
  - (c) In offer letter of appointment dated 23.09.2021 issued by the institution to the faculty, name is Dr. Krishnu Ganguly.

3. Faculty (Rupjyoti Saikia) appointed on 03.08.2018 i.e. after 09.06.2017, Ph.D./NET Certificate, educational qualification/testimonials are not attached with the reply of SCN.
4. As per previously submitted copy of approved faculty (Session 2021-2022) countersigned by Registrar, Dibrugarh University dated 22.10.2021 and latest copy of approved faculty (Session 2021-2022) countersigned by Registrar, Dibrugarh University dated 03.01.2022 in respect of same faculties in Music, Fine/Performing Arts and Physical Education, the following discrepancies found :

(a) Lecturer in Music (Smriti Rekha Boruah):

Earlier shown in the list Date of appointment as 10.08.2017 and date of joining as 08.08.2017 (two days prior to date of appointment). Now tampering made applying white correction fluid showing in the list Date of appointment as 08.04.2017 and date of joining as 08.04.2017.

(b) Lecturer in Fine Arts (Birinchy Borah):


Earlier shown in the list Date of appointment as 02.11.2020 and date of joining as 01.11.2010 (one day prior to date of appointment). Now tampering made applying white correction fluid showing in the list Date of appointment as 01.11.2020 and date of joining as 01.11.2020. Subject of teaching shown as teaching of performing Arts.

(c) Lecturer in Physical Education (Dimba Borah):

Earlier shown in the list Date of appointment as 05.08.2019 and date of joining as 01.08.2019 (four days prior to date of appointment). Now tampering made applying white correction fluid showing in the list Date of appointment as 01.08.2019 and date of joining as 01.08.2019.

Hence, recognition granted to B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session 2022-2023. On withdrawal of recognition, the affiliation, if any granted under Clause 8(10) of NCTE Regulations, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to apply for counselling from the next academic session i.e. 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.

10. NOW THEREFORE, recognition granted to Namrup College of Teacher's Education, P.O. Parbatpur, Dist. Dibrugarh, Assam - 786623 for B.Ed. Course is hereby withdrawn in terms of Section 17(1) of NCTE Act, 1993 with effect from the next academic session 2022-2023 as per the above decision taken by ERC.

11. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.

The original FDRs of Rs.5.00 lakh bearing A/c No.34208047179 dated 08.09.2014 and Rs.3.00 lakh bearing A/c No.34170320807 dated 09.09.2014 issued by State Bank of India have already been returned to the institution vide ERC letter F.No. AS-S/N-25/1996/27787 dated 13.11.2014.
