**ORDER**

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, **J.P. Shikshak Parishikhan Mahavidyalaya, Village - Biyabani, Street/Road- NH-31, Taluka/Mandal-Biharsharif, Town/City - Biyabani, District - Nalanda, Bihar - 803101** was granted recognition for B.Ed.programme of one year duration with an annual intake of 100 students *vide* ERC order No. ERC/7-159.2(ii).1.4/2013/Application Code No. ERCAPP1200/20191 dated 14.08.2013, followed by Revised order for B.Ed.programme of two year duration with an annual intake of 100 (two basic units) from the academic session 2015-2016 *vide* order No. F.ERC/NCTE/ ERCAPP1200/B.Ed.(Revised Order)/2015/31932 dated 23.05.2015, followed by an order for an additional intake of 50 students thereby making an annual intake of 150 students from the academic session 2018-2019 *vide* Order No. F.No.ERC/252.1(i).2/B.Ed.(Addl. Intake)/2018/56398 dated 03.03.2018, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, a letter No. NCTE-CDN016(13)/18/2018-CDN-HQ dated 02.08.2018 was received from NCTE HQ. In compliance of the said letter, the matter was placed before 284<sup>th</sup> meeting of ERC-NCTE held on 17-18 September, 2020 and the Committee decided to issue the Show Cause Notice to the institutions which have been recognized without NET qualified teachers. Accordingly, SCN was issued to the institution on dated 28.09.2020. The reply of the institution was received in ERC on 03.11.2020.

3. **AND WHEREAS**, the matter was placed before ERC in its 303<sup>rd</sup> (Virtual) meeting held on 24<sup>th</sup> March, 2022 and the committee decided to issue final Show Cause Notice under Section 17(1) of the NCTE Act, 1993 be issued to all ninety seven (97 TEIs). Accordingly, Final Show Cause Notice was issued to the institution on dated 09.04.2022. The reply of the institution was received in ERC on 18.05.2022.

4. **AND WHEREAS**, , the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 332<sup>nd</sup> (virtual) meeting held on 30<sup>th</sup> August, 2023 and the Committee observed that:

*The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered in reference to the Final Show Cause Notice dated 09.04.2022 and the Committee observed that:*

- *The institution has not submitted the latest faculty list after the date of issue of Final SCN on 09.04.2022.*

- *Further, as per faculty list for the session 2017-19, the institution had appointed 3 faculties (S. N 06 to 08) for Sociology/ Philosophy/ Psychology. However, as per Appendix-4 to the extant NCTE Regulations 2014, maximum 02 faculty positions may be appointed with 03 years of teaching experience in secondary school. The institution has not submitted the experience certificates for these faculty for three years of teaching experience in a secondary school as required under NCTE Regulations, 2014.*
- *The faculty at Sl. Nos. 22-24 were appointed on 03.02.2020 whereas the faculty is for the session 2017-19.*
- *The institution website is [www.jpspm.ac.in](http://www.jpspm.ac.in). However, the institution has not uploaded the latest faculty list on their college website and the additional information as per Clause 7(14), 8(6) 10 (3) of the NCTE Regulation 2014 and Clause 2 (C) of the NCTE Regulations dated 28.04.2017.*

*Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.*

Accordingly, withdrawal order was issued to the institution on dated 18.09.2023.

5. **AND WHEREAS**, the institution preferred an appeal against the ERC withdrawal Order dated 18.09.2023. The Appellate Committee *vide* Order No. File No.89-205/E-320632/2023 Appeal/14<sup>th</sup> Meeting, 2023 APPLERC202314717/122667 dated 10.11.2023, decided as under:

*“After Perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to ERC with direction to verify the submitted documents filed by the Appellant institution with Appeal from the records available with ERC and if it feel necessary and appropriate then documents may also be verified from the concerned competent authority. The Appellant institution is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the ERC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time in terms of direction given herein above.”*

6. **AND WHEREAS**, the reply of institution received in ERC office on dated 22.11.2023 was considered by the ERC in its 339<sup>th</sup> meeting of the ERC held on 13.02.2024 and the Committee decided as under:-


*The original file of the institution alongwith Appeal Order, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.*

- *The Committee noted that the withdrawal order 18.09.2023 has already been set aside by the Appellate Authority vide its Order dated 10.11.2023 and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running B.Ed. programme is restored until a fresh withdrawal order is issued by ERC. Order be issued accordingly.*
- *The Committee further decided that the documents submitted by the institution in compliance of the appeal order be verified by the concerned competent authority and a copy of these communications may also be endorsed to the State Government.*

7. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to the institution viz **J.P. Shikshak Parishikhan Mahavidyalaya, Village - Biyabani, Street/Road- NH-31, Taluka/Mandal-Biharsharif, Town/City - Biyabani, District - Nalanda, Bihar** - for B.Ed. programme of two year duration with an annual intake of 150 (three basic units) vide Order No. F.ERC/NCTE/ ERCAPP1200/B.Ed.(Revised Order)/2015/31932 dated 23.05.2015 and Order No. F.No.ERC/252.1(i).2/B.Ed.(Addl. Intake)/2018/56398 dated 03.03.2018 is hereby restored until a fresh withdrawal order is issued by ERC.

Also order that a copy of this Order be published in the Official Gazette.
