ORDER

WHEREAS, Jamshedpur Women's College, Vill./PO.-Bistupur, Tehsil/Taluka- Bistupur, Town/City-Jamshedpur, Dist.- Purba Singhbhum, Jharkhand –831037 (Code No. APE00410 & ERCAPP1021) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2005-2006 vide ERC Order No. 12646 dated 19.07.2012, followed by revised order vide No.32581 dated 31.05.2015 with an annual intake of 200 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 271st meeting held on 24th – 25th April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 21.05.2019 to the institution on the following grounds:

- (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the concerned competent Govt. Engineer/ Authority.
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/ Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all detail along with affidavit.

3. **AND WHEREAS**, the ERC in its 272nd Meeting held on 30th May – 1st June, 2019 considered the matter along with the reply dated 20.05.2019 and received in this office on 27.05.2019 submitted by the institution in response to Show Cause Notice and observed as under:

- a) Show Cause Notice u/s 17(1) was issued on 20.04.2018 & 18.05.2019.
- b) The submitted faculty list dated 20.05.2019 signed by Principal is neither in accordance with the NCTE prescribed proforma nor approved by the concerned affiliating body.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to **B.Ed. course** of the application bearing Code No. **APE00410 & ERCAPP1021** is **withdrawn** under section 17(1) of NCTE Act, 1993 **from the academic session 2020-2021**.

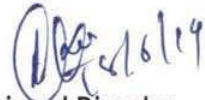

4. **NOW THEREFORE**, recognition granted to the institution viz. **Jamshedpur Women's College, Vill./PO.-Bistupur, Tehsil/Taluka- Bistupur, Town/City-Jamshedpur, Dist.- Purba Singhbhum, Jharkhand -831037 (Code No. APE00410 & ERCAPP1021)** for **B.Ed. Course** is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 **with effect from the end of the academic session next following the date of communication of such order i.e. from 2020-2021.**

5. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.

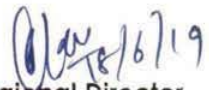
