ORDER

WHEREAS, Jamshedpur Women's College, Vill/Po-Bistupur, Tehsil/Taluka- Bistupur, Town/City-Jamshedpur, Dist.- Purba Singhbhum, Jharkhand -831037 (Code No.APE00410 & ERCAPP1021) was granted recognition for B.Ed. course with an intake of 100 from the academic Session 2005-2006 vide ERC Order No. 2646 dated 10/12/2004, followed by revised order vide No.32581 dated 31/05/2015 an intake of 200(four basic units) from the academic Session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, Recognition of B.Ed. Course (100 intakes) is Withdrawn vide Order No. 60846 dated 19/06/2019 as per the decision of 272nd ERC meeting held on 30th - 1st June, 2019 on the following grounds:-

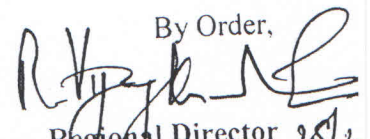
- (i) Show Cause Notice u/s 17(1) was issued on 20/04/2018 & 18/05/2019.
- (ii) The submitted faculty list dated 20.05.2019 signed by Principal is neither in accordance with the NCTE prescribed proforma nor approved by the concerned affiliating body.

3. AND WHEREAS, the institution has preferred an appeal Order No. F.No.89-379/E 136535 /2019 Appeal/ 34th Mtg. 2019/22nd November, 2019/85882 dated 05/12/2019 against the ERC withdrawn order dated 19/06/2019

4. AND WHEREAS, the ERC in its 279th Meeting held on 14th - 16th February, 2020 considered the matter the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 05/12/2019, were carefully considered by ERC and decided as under:-

➤ Restoration of recognition order of B.Ed. course to be issued.

6. NOW THEREFORE, recognition granted to the institution viz. Jamshedpur Women's College (Code No. APE00410 & ERCAPP1021) for B.Ed. course is hereby restored with the effect from the session 2020-2021. Now, the institution may be run at the aforesaid address henceforth from the date of issue of this order.

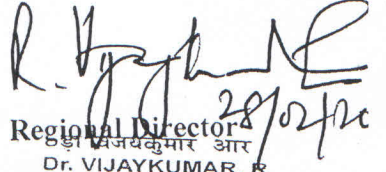
