ORDER

WHEREAS, Swami Sahajanand Saraswati B.Ed. College, Plot No. 972 to 978, 1011-12, 1020 to 1054, Street No. Sector 8B, Vill- Bokaro Steel City, Po- Sector-9, Tehsil- Chas, CityBokaro Steel City, Dist.- Bokaro, Jharkhand- 827009 (Code No. ERCAPP1185) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC Order No. 15784 dated 18.01.2013, followed by revised order vide No.32281 dated 27.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 272nd meeting held on 30th – 31st May & 1st June 2019, considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 19.06.2019 to the institution on the following grounds:

- (i) Faculty list is not submitted.
- (ii) Blue print of building plan is not submitted.
- (iii) Building Completion certification in accordance with the NCTE prescribed proforma signed by Govt. Engineer is not submitted.

3. **AND WHEREAS**, the ERC in its 274th Meeting held on 15th -16th July, 2019 considered the matter along with the reply dated 12/06/2019 submitted by the institution in response to Show Cause Notice and observed as under:

- (i) 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 19.06.2019 and the institution is still deficient on the following grounds:-

- a) Building plan is not approved by Govt. Engineer.
- b) Building Completion certificate signed by Govt. Engineer.
- c) Website not maintained and updated.

In view of the above, the Committee decided as under:

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

4. **NOW THEREFORE**, recognition granted to the institution viz. **Swami Sahajanand Saraswati B.Ed. College, Plot No. 972 to 978, 1011-12, 1020 to 1054, Street No. Sector 8B, Vill- Bokaro Steel City, Po- Sector-9, Tehsil- Chas, CityBokaro Steel City, Dist.- Bokaro, Jharkhand- 827009 (Code No.ERCAPP1185) for B.Ed. Course is hereby withdrawn** under section 17(1) of NCTE Act, 1993 **with effect from the academic session 2020-2021.**

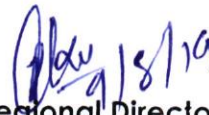
