ORDER

WHEREAS, Swami Sahajanand Saraswati B.Ed. College, Plot No.- 972 to 978, 1011-12, 1020 to 1054, Vill.- Bokaro Steel City, P.O.- Sector 9, Tehsil/Taluka- Chas, Town/City-Bokaro Steel City, Dist.- Bokaro, Jharkhand- 827009 (Code No. ERCAPP1185) was granted recognition for B.Ed. course of one year duration with an annual intake of 100 vide ERC order No.15784 dated 18.01.2013 from the academic session 2013-2014.

2. AND WHEREAS, Revised Recognition Order (RRO) was issued to the institution vide ERC order No.32281 dated 27.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

3. AND WHEREAS, the ERC in its 274th meeting held 15th – 16th July, 2019 considered the matter and as decided, recognition to B.Ed. Course was withdrawn u/s 17(1) vide order No. 61257 dated 13.08.2019 from the academic session 2020-2021 on the following grounds:-

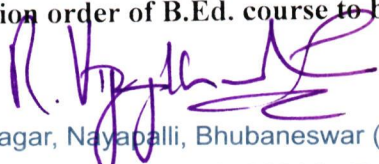
- (i) Building plan is not approved by Govt. Engineer.
- (ii) Building completion certificate is not signed by Govt. Engineer.
- (iii) Website not maintained and updated.

4. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 13.08.2019. The Appellate Authority vide its Order No.89-309/E-127853/2019 Appeal/32nd Mtg.-2019/17th October, 2019 dated 06.11.2019 remanded back the case to ERC, for revisiting the matter after verifying that website of the appellant institution is functional. Appellant institution is required to submit to ERC copies of Building Plan, BCC and printout of website within 15 days of the issue of appeal order.

5. AND WHEREAS, on the direction of Appellate Authority, the institution submitted representation vide letter dated 09.11.2019 received in ERC, NCTE on 13.11.2019. The ERC in its 277th meeting held on 19th – 20th Dec, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 26.12.2019 to the institution.

6. AND WHEREAS, the institution submitted reply vide letter dated 11.01.2020 received in ERC, NCTE on 16.01.2020. The ERC in its 280th Meeting held on 29th February 1st March, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and decided as under:-

Restoration of recognition order of B.Ed. course to be issued.



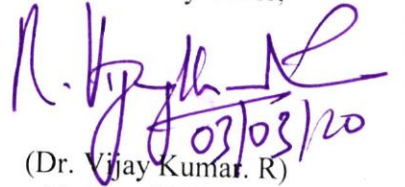

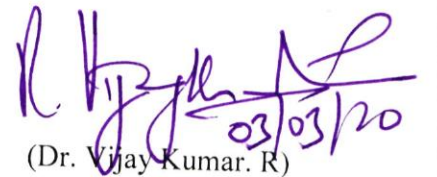
