CORRIGENDUM ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, recognition was granted to Jamshedpur Women's College, Plot No- 3229,3290,3231-35,3137-39, Khata No-85, Village-Bistupur, P.O.- Bistupur, Tehsil/Taluka-Bistupur, Town/City-Jamshedpur, District-Purba Singhbhum, Jharkhand-831037, were granted recognition for the following programme:-

- I. **B.Ed** programme of one year duration *vide* Order no. ERC/7-51(ER-51.7.7)/2024/3623/9 dated 10.12.2004 followed by Revised Recognition Order *vide* Order No. ERC/NCTE/APE00410/ERCAPP1021/ B.Ed.(Revised Order)/2015/32581 Dated 31.05.2015 of two year duration with annual intake 200 student (four basic units of 50 students each for academic session 2015-2016.
 - II. **M.Ed** programme of one year duration *vide* Order No. ERC/7-94.6(II).5/2009/15793 dated 23.03.2009 followed by the Revised Recognition Order *vide* Order No. F.ERC/NCTE/APE00509/M.Ed.(Revised Order)/2015/32611 dated 31.05.2015 of two year duration with annual intake 50 Student (one basic unit) from the academic session 2015-2016.
 - III. **B.P.Ed.** programme of two year basic units with annual intake 100 students *vide* order no. ER-239.6.45.(Part-2)/ID No.9625/B.P.Ed./2017/52834 dated 02.05.2017 as per NCTE Regulations, 2014.
2. **AND WHEREAS**, the recognition of the institution was withdrawn for B.Ed. course by ERC in its 272th Meeting held on 30th & 31st & 01st June 2019 *vide* Order No. F.No. ER-272.14.91/(APE00410 & ERCAPP1021)/B.Ed./2019/60846 Dated 19.06.2019 from the session 2020-2021
3. **AND WHEREAS**, the institution preferred an appeal before NCTE (HQ) against Withdrawal Order of ERC dated 19.06.2019 and the Appellate Authority decided to remand back the case to ERC.
4. **AND WHEREAS**, the ERC in its 279th meeting held on 14-16th February, 2020 considered the matter, the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by the NCTE from time to time and appeal order dated 05.12.2019 were carefully considered by ERC and recognition of the institution was restored. Accordingly, Restoration Order *vide* Order No. F.No.ER-279.106(APE00410 & ERCAPP1021)/B.Ed./2020/62460 dated 28.02.2020 was issued for B.Ed programme to the institution.
5. **AND WHEREAS**, A Letter has been received from the institution dated 18.04.2024 Requesting for change in the name of institution from Jamshedpur women's College to Jamshedpur Women's University, Jamshedpur and Affiliating Body from Kolhan University to Jamshedpur Women's University, Jamshedpur.
6. **AND WHEREAS**, the matter was considered by the ERC in its 347th meeting of the ERC held on 11.07.2024 and committee decided to issue Show cause notice. **Accordingly**, Show Cause Notice dated 11.09.2024 was issued to the institution.

7. **AND WHEREAS**, the institution has submitted reply dated 09.09.2024 received in ERC office on 25.09.2024 on the basis of minutes uploaded at ERC-NCTE website.. The matter was considered by ERC in its 352nd meeting held on 15-16th October 2024 and the committee decided as under:

“The original application of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were considered by ERC and the Committee noted and decided the following: -

- *The ERC noted that Jamshedpur Women’s College has become Jamshedpur Womens University vide State Act and the courses i.e. B.Ed., M.Ed and B.P.Ed run by Jamshedpur Womens College comes under Department of Education, Jamshedpur Womens University.*
- *The request of the institution to convert Jamshedpur Womens College to Deptt of Education, Jamshedpur Womens University is permitted.”*

Accordingly, A letter was issued to the institution conveying the above decision vide order dated 12.12.2024.

8. **AND WHEREAS**, the institution has submitted an application dated 16.12.2025 regarding request for updating Recognition in the name of Jamshedpur women’s university from session 2021-2022. The matter was considered by ERC in its 387nd meeting held on 16th January 2026 and the committee decided as under:

Decision of ERC:

“The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, request of the institution dated 10.11.2025 regarding change in the name of the institution, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following:

- *The status of the institution was changed from ‘Jamshedpur Women’s College’ to Deptt. of Education, Jamshedpur Women’s University” as per decision of 352nd meeting of ERC held on 15th to 16th Oct, 2024.*
- *The decision of the 352nd meeting of ERC held on 15th to 16th Oct, 2024 are as under:*
 - (i) *The ERC noted that Jamshedpur Women’s College has become Jamshedpur Women’s University vide Sate Act and Courses i.e. B.Ed , M.Ed and B.P.Ed run by Jamshedpur Women’s College comes under Department of Education, Jamshedpur Women’s Universtiy.*
 - (ii) *The request of the institution to convert Jamshedpur Women’s College to Deptt. of Education, Jamshedpur Women’s University is permitted.*
- *Accordingly, a letter was issued to the institution conveying the above decision vide order date 12.12.2024.*
- *Now, the institution has submitted a request to update the recognition on your website, as issued in your order No. F.No. 352-66/NCTE/B.Ed/APE00410&ERCAPP1021/JH/2024/ NCTE/M.Ed/APE00509/JH/2024/NCTE/B.P.Ed/ERCAP201645128 (ID-9625)/JH/2024 /70080-70087) Dated 12/12/2014 reflecting the name of Jamshedpur Women’s University with effect from the session 2021-2022.*
