RESTORATION ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to **R S Teachers Training College, Plot No. 332, 333, 334, 338, 339, Vill./Po.-Katras Bazar, Tehsil/Taluka-Baghmara, City-Katras, Dist.-Dhanbad, Jharkhand-828114** for B.Ed. programme of one year duration with an annual intake of 100 seats *vide* order No. ERC/7-160.6.13/NCTE/B.Ed./2013/20578 dated 31.08.2013, followed by revised recognition for B.Ed. programme of two year duration with an intake of 100 students (two basic unit) from the academic session 2015-2016 *vide* order No. F.ERC/NCTE/ERCAPP1178/B.Ed.(Revised Order)/ 2015/32601 dt.31.05.2015, as per NCTE Regulations, 2014.

2. AND WHEREAS, the Appeal Committee of the Council *vide* its order No. F.No.89-95/ E-249519/2022 Appeal/5th Meeting 2022/APPLERC202214329/112265 dated 12.07.2022 concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time.

3. AND WHEREAS, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 313th (virtual) meeting and the Committee decided to issued show cause Notice on certain grounds. Accordingly, Show Cause Notice dated 24.11.2022 was issued to the institution.

4. AND WHEREAS, the institution has submitted reply dated 16.12.2022 received in ERC office on 20.12.2022. The matter was placed before 358th meeting of ERC held on 06 February 2025 and the committee decided to issued final show cause notice. Accordingly, Final Show Cause Notice dated 21.02.2025 was issued to the institution.

5. AND WHEREAS, the institution has submitted reply dated 10.03.2025 received in ERC office on 21.03.2025. The matter was placed before 367th meeting of ERC held on 04th June, 2025 and the committee decided as under:

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- ***The institution has submitted reply to the final show cause notice.***

After carefully observing the reply to the final show cause notice, the ERC concluded the following:



- *The institution has submitted Fire Safety Certificate dated 23.03.2017 issued by the Karyalaya Aghishthan Agnisham Padadhikari, Dhanbad which is very old.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

6. NOW THEREFORE, in term of above decision of ERC, the recognition granted to **R S Teachers Training College, Plot No. 332, 333, 334, 338, 339, Vill/Po-Katras Bazar, Tehsil/Taluka-Baghmara, City-Katras, Dist.-Dhanbad, Jharkhand-828114**, for running B.Ed. Programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order. Accordingly, withdrawal order was issued to the institution on 03.07.2025.

7. AND WHEREAS, the institution has preferred appeal before Appellate Authority, NCTE against the Order dated 03.07.2025 and the Appellate Authority, NCTE decided to remand back the case to ERC and the institution has submitted reply dated 06.08.2026 received in ERC office on 07.08.2026

8. AND WHEREAS, the matter was placed again in ERC in its 405th Meeting held on 19th Aug, 2026 and committee decided as under:-

"The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, Appeal Order passed by the NCTE-HQ, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

1. The Revised recognition order was issued for B.Ed programme for two units of the 100 students vide order dated 31.05.2015.
2. The show cause notice was issued to the institution on 24.11.2022 after consideration of the complaint against the institution in 313th meeting of ERC. Final Show Cause Notice was issued on 21.02.2025 as per decision of the 358th meeting of the ERC held on 06th Feb, 2025.
3. The Withdrawal order No F.No.ER-367.23/NCTE/ERCAPP1178/B.Ed./JH/2025 dated 03.07.2025 was issued to the institution on the ground of only non-submission of the "fire safety certificate" as per decision of the 367th meeting of ERC held on 04th June 2025.
4. The institution accordingly preferred appeal before Appellate Authority, NCTE-HQ against the order dated 03.07.2025 and the Appellate Authority, NCTE-HQ, passed an order vide Order No. File No. No. 89-355/E-376986/2025 Appeal/12th (Emergent) Meeting, 2026 APPLERC202515282 Dated 05.08.2026 which is as under:

"After careful consideration of the Appeal Report, the impugned order, the records available on file, and the submissions made by the appellant institution, the Appeal Committee of the Council, in exercise of its appellate jurisdiction under Section 18 of the NCTE Act, 1993, sets aside the impugned order dated 03.07.2025 and remands the matter to the Eastern Regional Committee for fresh consideration and re-examination in accordance with the provisions of the NCTE Act, 1993 and the NCTE Regulations, 2014 (as amended), subject to the directions contained herein. The appellant institution shall submit the requisite documents within fifteen (15) days, whereupon the Regional Committee shall proceed in accordance with law and pass a reasoned and speaking order within the stipulated timeframe."

5. The institution has submitted its reply vide representation dated 06.08.2026 along with a copy of the Fire Safety Certificate dated 28.05.2026 which is valid up to 27.05.2027 issued by the Prabhari Upar Rajya Agnishaman Padh adhikari, Ranchi, Jharkhand.
6. The Committee considered the same and found fit the case for continuation of recognition of the institution for B.Ed. Programme.

In view of the above, the Committee has decided that the recognition of the institution granted vide order no. F.ERC/NCTE/ERCAPP1178/B.Ed. (Revised Order)/2015/32601 dated 31.05.2015 be restored for B.Ed. programme with annual intake of 100 seats. Concerned Affiliating Body be informed accordingly".

9. NOW THEREFORE, recognition granted to the institution viz R S Teachers Training College, Plot No. 332, 333, 334, 338, 339, Vill./Po.-Katras Bazar, Tehsil/Taluka-Baghmara, City-Katras, Dist.-Dhanbad, Jharkhand-828114 for conducting B.Ed. programme of one year duration with an annual intake of 100 seats vide order No. ERC/7-160.6.13/NCTE/B.Ed./2013/20578 dated 31.08.2013, followed by revised recognition for B.Ed. programme of two year duration with an intake of 100 students (two basic unit) from the academic session 2015-2016 vide order No. F.ERC/NCTE/ERCAPP1178/B.Ed.(Revised Order)/ 2015/32601 dt.31.05.2015, is hereby restored.

Also order that a copy of this Order be published in the Official Gazette.
