WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, **N.N. Ghosh Sanatan Teacher Training College**, Plot No. 165, Vill-Jamuary, P.O-Kokodro, Tehsil/Taluka-Kanke, Town/City-Ranchi, Dist-Ranchi, Jharkhand-834006 was granted recognition for conducting B.Ed. programme of two year duration with an intake of 100 students (two basic unit) from the academic session 2015-2016 vide. Order No. ER- F.No.ER-288.34/ERCAPP1221/B.Ed./2021/63544 Dated 03.02.2021 from the academic session 2021-2022, as per NCTE Regulation 2014.

2. **AND WHEREAS**, A letter vide letter no. NCTE-C/PG011/68/2025/131501 Complaint Section-HQ dated 29.07.2025 has been received from the Complaint Section, NCTE (HQ)

3. **AND WHEREAS**, The matter was placed before 374th meeting of ERC meeting held on 25-26th August 2025 and the Committee decided to issue to Show Cause Notice. Accordingly, Show Cause Notice dated 19.09.2025 was issued to the institution. However, the institution has submitted the reply dated 09.10.2025 received in ERC office on 27.10.2025.

5. **AND WHEREAS**, the matter was placed again in ERC in its 384th Meeting held on 09-10th December, 2025 and committee decided to issue Final Show Cause Notice. Accordingly, Final Show Cause dated 02.01.2026 was issued to the institution. However, the institution has not submitted the reply of Final Show cause Notice.

7. **AND WHEREAS**, the matter was placed before ERC in its 390th Meeting held on 09th February, 2026 and committee decided as under:-

Decision of ERC:

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- *First SCN was issued to the institution on 18.09.2025 on certain grounds. The institution has submitted the reply dated 09.10.2025.*
- *Thereafter, the final SCN was issued to the institution on 02.01.2026 as per decision of the 384th meeting of ERC held on 09th -10th December, 2025. However, the institution has not submitted reply to Final SCN which was issued on 02.01.2026.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of the academic session next following the date of communication of withdrawal order.

8. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted **N.N. Ghosh Sanatan Teacher Training College**, Plot No. 165, Vill-Jamuary, P.O-Kokodro, Tehsil/Taluka-Kanke, Town/City-Ranchi, Dist-Ranchi, Jharkhand-834006 for running B.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

09. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

10. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
