WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, **Elias Chowdhury Academy, Plot No- 2430, Vill/PO- Barala, Tehsil/Taluka- Raghunathganj-I, Town/City- Jangipur, Dist- Murshidabad, West Bengal- 742235** was granted recognition for B.Ed. programme of two year duration with an annual intake of 100 students (two basic units) from the academic session 2016-2017 vide ER-213.6(i).93/ERCAPP3586/B.Ed./2016/46246 dated 02.05.2016 and vide Order No. F.No.213.6(i).92/ERCAPP3585/D.El.Ed./2016/46345 dated 02.05.2016 for D.El.Ed. programme of two year duration with an intake of 100 (two basic units) from the academic session 2017-2018 as per NCTE Regulations, 2014.

2. **AND WHEREAS**, two complaints dated 01.09.2023 & 03.10.2023 received from the Registrar of Baba Saheb Ambedkar Education University (BSAEU) in the office of ERC against the existing teacher training institutions regarding short comings/deficiencies prevailing in the institutions.

3. **AND WHEREAS**, the aforesaid complaint was considered by ERC in its 336th meeting held on 20th December, 2023, and the Committee decided that Show Cause Notice under section 17 of NCTE Act, 1993 be issued to the institution on the following grounds:-

Accordingly, Show Cause Notice dated 07.02.2024 was issued to the institution.

4. **AND WHEREAS**, the institution has submitted reply dated 15.02.2024 and another complaint has been received from the complainant Sh. Suman Das vide letter dated 15.01.2024 in ERC office. The matter was placed before 358th meeting of ERC meeting held on 06 February 2025 and the committee decided as under:

"The original file of the institution alongwith other related documents, NCTE Act, 1993, SCN reply dated 15.02.2024, Complaint Letter dated 15.01.2024, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC:

1. *A copy of FDRs towards Endowment Fund and Reserve Fund be forwarded to concerned bank for authentication/verification.*
2. *The institution is required to submit copies of appointment letters and joining reports clearly mentioning the name and Saving Bank account number of each of the faculty appointed for B.Ed./D.El.Ed. programme and also stating therein that the faculties are being paid salary through cheque/RTGS/NEFT. It should be supported with documents like photocopy of passbook of each of faculty, showing the disbursement of salary through bank account to individual faculty members for last six months.*

3. *A copy of updated Teaching faculty issued by the Registrar of the concerned affiliated university/affiliating body alongwith with PAN card copies is required to be submitted for B.Ed and D.El.Ed programme.*

In view of the above, the Committee has decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice on the above deficiencies."

Accordingly, Final Show Cause Notice dated 07.02.2024 was issued to the institution.

5. **AND WHEREAS,** the institution has submitted reply dated 08.03.2025 received in ERC office on 17.03.2025. The matter was placed before 368th meeting of ERC meeting held on 17th -18th June, 2025 and the committee decided as under:

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- *The complaints against the TEI has been forwarded by the Complaint Division.*
- *The institution has furnished reply of the First SCN on 07.02.2024 and of Final SCN on 21.02.2025.*

After carefully observing the reply to Final SCN along with other related documents, the ERC concluded that the institution is still deficient on the following grounds:-

1. *The institution has not submitted copies of Saving Bank Account numbers in r/o each of the faculties appointed for B.Ed./D.El.Ed. programme and the documents stating therein that the faculties are being paid salary through cheque /RTGS/NEFT for the last six months.*
2. *The institution has not submitted PAN card of the teaching staff namely Md. Asif Sahriar, Dr. Wasim Khan and Mr. Supriyo Manna.*

In view of above, the Committee has decided that recognition granted to the institution for running B.Ed and D.El.Ed Programme be withdrawn under section 17 of the NCTE Act, 1993 with effect from the end of the session next following the date of communication of withdrawal order.

6. **NOW THEREFORE,** in term of above decision of ERC, the recognition granted tor **Elias Chowdhury Academy, Plot No- 2430, Vill/PO- Barala, Tehsil/Taluka- Raghunathganj-I, Town/City- Jangipur, Dist- Murshidabad, West Bengal- 742235** for running B.Ed. & D.El.Ed Programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

7. Further the institution and affiliating body are hereby informed about the following provision of Section 17(4) of NCTE Act:-

8. If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education

obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

9. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
