ORDER

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, **Elias Chowdhury Academy, Plot No- 2430, Vill/PO- Barala, Tehsil/Taluka- Raghunathganj-I, Town/City- Jangipur, Dist- Murshidabad, West Bengal- 742235** was granted recognition for B.Ed. programme of two year duration with an annual intake of 100 students (two basic units) from the academic session 2016-2017 vide ER-213.6(i).93/ERCAPP3586/B.Ed./2016/46246 dated 02.05.2016 and vide Order No. F.No. 213.6(i).92/ERCAPP3585/D.El.Ed./2016/46345 dated 02.05.2016 for D.El.Ed. programme of two year duration with an intake of 100 (two basic units) from the academic session 2016-2017 as per NCTE Regulations, 2014.

2. **AND WHEREAS**, two complaints dated 01.09.2023 & 03.10.2023 received from the Registrar of Baba Saheb Ambedkar Education University (BSAEU) in the office of ERC against the existing teacher training institutions regarding short comings/deficiencies prevailing in the institutions.

3. **AND WHEREAS**, the aforesaid complaint was considered by ERC in its 336th meeting held on 20th December, 2023, and the Committee decided that to issued Show Cause Notice.

Accordingly, Show Cause Notice dated 07.02.2024 was issued to the institution.

4. **AND WHEREAS**, the institution has submitted reply dated 15.02.2024 and another complaint has been received from the complainant Sh. Suman Das vide letter dated 15.01.2024 in ERC office. The matter was placed before 358th meeting of ERC meeting held on 06 February 2025 and the committee decided to issue Final Show Cause Notice.

Accordingly, Final Show Cause Notice dated 21.02.2024 was issued to the institution.

5. **AND WHEREAS**, the institution has submitted reply dated 08.03.2025 received in ERC office on 17.03.2025. The matter was placed before 368th meeting of ERC meeting held on 17th - 18th June, 2025 and the committee decided as under:

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- *The complaints against the TEI has been forwarded by the Complaint Division.*
- *The institution has furnished reply of the First SCN on 07.02.2024 and of Final SCN on 21.02.2025.*

After carefully observing the reply to Final SCN along with other related documents, the ERC concluded that the institution is still deficient on the following grounds:-

1. *The institution has not submitted copies of Saving Bank Account numbers in r/o each of the faculties appointed for B.Ed./D.El.Ed. programme and the documents stating therein that the faculties are being paid salary through cheque /RTGS/NEFT for the last six months.*

2. *The institution has not submitted PAN card of the teaching staff namely Md. Asif Sahriar, Dr. Wasim Khan and Mr. Supriyo Manna.*

In view of above, the Committee has decided that recognition granted to the institution for running B.Ed and D.El.Ed Programme be withdrawn under section 17 of the NCTE Act, 1993 with effect from the end of the session next following the date of communication of withdrawal order.

Accordingly, Withdrawal order dated 14.07.2025 was issued to the institution.

6. **AND WHEREAS,** the Institution preferred appeal before NCTE Appellate Authority against the order dated 14.07.2025. The Appellate Authority, NCTE passed an order vide Order No.89-310/E-374324/2025 Appeal/9th Meeting, 2025 APPLERC202515281/32768 dated 16.09.2025.

7. **AND WHEREAS,** the institution has submitted the reply dated 19.09.2025 & 21.09.2025 received in the office of ERC-NCTE on 23.09.2025.

8. **AND WHEREAS,** the matter was placed before ERC in its 379th Meeting held on 30th September, 2025 and the committee decided as under:

Decision of ERC

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, Appeal Order passed by the NCTE-HQ, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- *The recognition was granted to the institution for B.Ed and D.El.Ed programe with intake of two units each from the academic session 2016-2017.*
- *The recognition of the B.Ed and D.El.Ed programme was withdrawn by ERC due to certain reason as per decision of ERC-NCTE in its meeting 368th held on 17th and 18th June, 2025.*
- *Accordingly, Withdrawal Order was issued to the institution vide Order dated 15.05.2025*
- *The institution has filed an appeal against the order No. F.No.368.3/NCTE/B.Ed & D.El.Ed/ERCAPP3585/WB/2025/71300-71307 dated 14.07.2025 before NCTE Appellate Authority and the NCTE Appellate Authority decided as under: -*

After perusal of the appeal report, documents on record, and oral argument advanced during the online hearing, Appeal committee of the council concluded to set aside the impugned order dated 14.07.2025 and remand back the case to Eastern Regional Committee with the directions to verify the documents submitted in Appeal and then appropriate action shall be taken by the ERC as per provision of the NCTE Regulation. The appellant institution is directed to forward to the ERC the documents submitted in within fifteen (15) days of receipt of the order of the appeal and after receipt of the same the ERC to take further necessary action as per NCTE Regulation 2014 guidelines and amendments issued from time to time as per direction given herein above.

- In compliance of the appeal order the institution has submitted its reply dt. 19.09.2025 and 21.09. 2025.

In view of the above, the Committee decided the recognition of the institution be restored in the light of decision of Appellate Authority for B.Ed and D.El.Ed programme. Concerned affiliating body be informed accordingly.

9. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to , Elias Chowdhury Academy, Plot No- 2430, Vill/PO- Barala, Tehsil/Taluka- Raghunathganj-I, Town/City- Jangipur, Dist- Murshidabad, West Bengal- 742235 for conducting B.Ed. programme of two years duration vide Order No. ER-213.6(i).93/ERCAPP3586/B.Ed./2016/46246 dated 02.05.2016 and for D.El.Ed. Programme vide Order No. F.No. 213.6(i).92/ERCAPP3585/D.El.Ed./2016/46345 dated 02.05.2016 is hereby restored.

Also order that a copy of this Order be published in the Official Gazette.
