ORDER

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, **Aditya Prakash Jalan Teachers Training College, Plot No.- 1125, Vill.- Kudlun, PO.- Balalong, Tehsil/Taluka- Ratu, Town/City- Ranchi, Dist.-Ranchi, Jharkhand- 834004** was granted recognition vide Order No.- F.ERC/NCTE/ERCAPP696/B.Ed./ (Revised Order)/2015/31748 dated 20.05.2015 for B.Ed. programme of two year duration with an annual intake of 100 students (Two Basic Unit) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHEREAS**, a complaint letter no. F.No. NCTE-C/PG012/38/2024-Complaint Section-HQ/127287 dated 17.10.2024 has been received from the Complaint Section, NCTE. The matter was placed before 358th meeting of ERC held on 06 February 2025 and the committee decided as under:

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Complaint Letter dated 17.10.2024, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC:

- *The institution is required to submit copies of appointment letters and joining reports clearly mentioning the name and Saving Bank account number of each of the faculty appointed for B.Ed. programme and also stating therein that the faculties are being paid salary through cheque/RTGS/NEFT. It should be supported with documents like photocopy of passbook of each of faculty, showing the disbursement of salary through bank account to individual faculty members for last six months.*
- *A copy of updated Teaching faculty issued by the Registrar of the concerned affiliated university/body alongwith with PAN card copies is required to be submitted.*
- *Mr. Kamendra Nath Tripathi is working in the said college as well as Devi Ahilya Univeristy, Nalanda Campus, RNT Marg, Chhoti Gwaltoli, Indore, Madhya Pradesh-452001, (Both institution)*
- *A copy of complaint be forwarded to the institution with a direction to submit comments within 21 days from the date of the issue of the letter for taking appropriate action in this regard.*

In view of the above, the Committee has decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 21 days from the date of issue of show cause notice on the above deficiencies.”

4. **AND WHEREAS**, the institution has not submitted reply of Show Cause Notice which was issued on 21.02.2025 within the stipulated time.

5. **Accordingly**, Final Show Cause Notice dated 24.03.2025 was issued to the institution. The institution has submitted the reply dated 09.04.2025 received in ERC office on 16.04.2025.

6. **AND WHEREAS**, the matter was placed before ERC in its 368th Meeting held on 17th -18th June, 2025 and committee decided that:-

“The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- The complaints against the TEI has been forwarded by the Complaint Division.
- The institution has furnished reply of the First SCN on 21.02.2025 and of Final SCN on 09.04.2025.

After carefully observing the reply to Final SCN along with other related documents, the ERC concluded that the institution is still deficient on the following grounds: -

- The institution has submitted a list of teaching faculties without seal of the Registrar of the affiliating University.
- The institution has submitted copies of appointment letters and joining reports in r/o only fifteen teaching faculties whereas that of the total teaching faculties ie. one principal and fifteen teaching faculty is required.
- The institution has submitted teaching faculty list wherein dates of joining of the teaching faculties at S.No. 08 to 16 is not mentioned.

In view of above, the Committee has decided that recognition granted to the institution for running B.Ed Programme be withdrawn under section 17 of the NCTE Act, 1993 with effect from the end of the session next following the date of communication of withdrawal order.

Accordingly, Withdrawal Order dated 14.07.2025 was issued to the institution.

7. **AND WHEREAS**, the institution has preferred appeal before Appellate Authority, NCTE against the Order dated 14.07.2025 and the Appellate Authority, NCTE decided to remand back the case to ERC.

8. **AND WHEREAS**, the institution has submitted reply/documents dated 30.09.2025 as per appeal order. The matter was placed before 379th meeting of ERC held on 30.09.2025 and the committee has decided as under:

“The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, Appeal Order passed by the NCTE-HQ, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- The recognition was granted to the institution for B.Ed Programme with intake of two units from the academic session 2015-2016.
- The recognition of the B.Ed programme was withdrawn by ERC due to certain reason as per decision of ERC-NCTE in its meeting 368th held on 17th and 18th June, 2025.
- Accordingly, Withdrawal Order was issued to the institution vide Order dated 14.07.2025
- The institution has filed an appeal against the order No. F.No.368.2/NCTE/ERCAPP696. B.Ed./JH/2025/71308-71314 dated 14.07.2025 before NCTE Appellate Authority and the NCTE Appellate Authority decided as under:-

“After perusal of the appeal report, documents on record, and oral argument advanced during the online hearing, Appeal committee of the council concluded to set aside the impugned order dated 14.07.2025 and remand back the case to ERC with the directions to carefully re-examine the matter verify the authentication and relevance of all document submitted and pass a reasoned order strictly in accordance with the provision of the NCTE Act, Rules and Regulations. The appellant institution is directed to forward to the ERC the documents submitted in within fifteen (15) days of receipt of the order of the appeal and after receipt of the same the ERC to take further necessary action as per NCTE Regulation 2014 guidelines and amendments issued from time to time as per direction given herein above.

- *In compliance of the appeal order the institution has submitted its reply dt. 30.09.2025, received in O/o ERC through whatsapp of CP/ERC.*

The Committee scrutinized the documents decided that the recognition of the institution be restored in the light of decision of appellate authority for B.Ed. programme. Concerned affiliating body be informed accordingly.

9. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to **Aditya Prakash Jalan Teachers Training College, Plot No.- 1125, Vill.- Kudlun, PO.- Balalong, Tehsil/Taluka- Ratu, Town/City- Ranchi, Dist.-Ranchi, Jharkhand- 834004** for conducting B.Ed. programme of two years duration is hereby restored.

10. Also order that a copy of this Order be published in the Official Gazette.
