WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to **Janardan College of Education**, Plot No.-143-45-46, Vill.- Gobindapur, P.O.-Birampur, Tehsil/Taluka-Birahimpur, Town/City-malda, Dist.- Malda, West Bengal-732207 for conducting B.Ed. programme of two year duration with an annual intake of 50 student (One Basic Unit) vide order No F. No. ER-183.6.2/ERCAPP122/2012/B.Ed/2015/30743 Date 03.03.2015 from the academic session 2015-2016, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, A letter vide letter no. F.No.NCTE-C/PG011/112//2025-Complaint Section-HQ/132587 Dated 11.09.2025 has been received from Complaint section, NCTE (HQ) Against Janardan College of Education regarding unauthorized use of Academic profile by TEI.

3. **AND WHEREAS**, the matter was placed before ERC in its 396th Meeting held on 07th May, 2026 and committee decided to issue first show cause notice to the institution on certain grounds. **Accordingly**, Show Cause Notice dated 20.05.2026 was issued to the institution and the institution has not submitted the reply.

4. **AND WHEREAS**, the matter was placed in ERC 398th Meeting held on 10-11th June, 2026, and committee decided as under:-

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, Complaint dated 11.09.2025 received from NCTE-HQ, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following:-

- First SCN was issued to the institution dated 20.05.2026. However, the institution has not submitted the reply.

In view of the above, the Committee decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 7 days from the date of issue of Show Cause Notice on the deficiencies mentioned above.

5. **Accordingly**, Final Show Cause Notice dated 18.06.2026 was issued to the institution and the institution has submitted reply dated 01.06.2026 received in ERC office on 17.06.2026.

6. **AND WHEREAS**, the matter was placed again in ERC 403rd Meeting held on 22-23rd July, 2026 and committee decided as under:-

The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the ERC after careful consideration made the following observations: -

1. *Final Show Cause Notice was issued to the institution on 18.06.2026. Accordingly, they have submitted the reply on 01.07.2026.*

After carefully observing the reply to Final SCN along with other related documents, the ERC concluded that the institution is still deficient on the following grounds: -

- 1. The institution is required to submit latest teaching faculty approved from concerned affiliating Body in the prescribed format for B.Ed. Course.*
- 2. The institution is required to submit documents/bank statements duly certified by the bank establishing that the faculties are being paid salary through cheque/RTGS/NEFT for the last six months.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the academic session 2027-2028.

7. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to **Janardan College of Education**, Plot No.-143-45-46, Vill.- Gobindapur, P.O.-Birampur, Tehsil/Taluka-Birahimpur, Town/City-malda, Dist.- Malda, West Bengal-732207 for running running B.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

9. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
