WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15(3) of the NCTE Act, 1993, **Dev Sangha Institute of Professional Studies and Educational Research**, Po – Dev sangha – Bompas town, District – Deoghar, Jharkhand-814114 was granted recognition for:

- B.Ed. programme** of one year duration with an annual intake of 100 (one hundred) seats *vide* Order No. ERC/7-46(ER-46.6.4)/2004/2094 dated 12.07.2004 from the academic session **2004-2005** and additional intake of 100 seats, thus making total annual intake of 200 (two hundred) seats *vide* Order No ERC/7-140.6.23/NCTE/B.Ed./2012/13698 dated 25.08.2012 from the academic session **2012-2013** followed by Revised Recognition with an annual intake of 200 intake (four basic units) seats *vide* Order No F.ERC/NCTE/APE00219 & ERCAPP1074/B.Ed.(Revised Order)/2015/32749 dated 31.05.2015 from the academic session **2015-2016**.
- D.El.Ed. programme** of two year duration with an annual intake of 50 (one basic unit) seats *vide* Order No. ERC/7-55.6(8)/2005/1270 dated 20.04.2005 from the academic session **2005-2006**.
- M.Ed. programme** of one year duration with an annual intake of 25 (Twenty Five) seats *vide* Order No. ERC/7-83.6.(III)/1/2008/102088 dated 28.02.2008 from the academic session **2008-2009**, followed by Revised Recognition with an annual intake of 50 (one basic unit) seats *vide* Order No .ERC/NCTE/APE00735/M.Ed.(Revised Order)/ 2015/32690 dated 31.05.2015 for conducting M.Ed. programme of two year duration from the academic session **2015-2016** as per NCTE Regulations, 2014.

2. **AND WHEREAS**, a complaint *vide* letter no. NCTE-C/PG011/88/2023-Complaint Section-HQ/121408 dated 12.09.2023 was received from NCTE(HQ) thereby forwarding the complaint dated 04.07.2023 requesting for strict action against the institution.

3. **AND WHEREAS**, the aforesaid complaint was considered by ERC in its 333rd (Virtual) meeting held on 27th September, 2023, and the committee decided that show cause notice under section 17(1) of NCTE Act, 1993.

4. **Accordingly**, Show Cause Notice dated 17.10.2023 was issued to the institution. The institution has submitted the reply dated 26.10.2023 & 14.12.2024 to the office of ERC-NCTE.

5. **AND WHEREAS**, The matter was placed before ERC in its 358th Meeting held on 06th February, 2025 and the committee decided to issue Final Show Cause Notice.

6. **Accordingly**, Final Show Cause Notice dated 21.02.2025 was issued to the institution. The institution has submitted the reply dated 06.03.2025 received in ERC office on 21.03.2025.

7. **AND WHEREAS**, the matter was placed before ERC in its 382th Meeting Held on 17th November, 2025 and committee decided as under:-

Decision of ERC:

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- *First SCN was issued to the institution on 17.10.2023 and Final SCN was issued to the institution on 21.02.2025. The institution has submitted reply on 06.03.2025*

After carefully observing the reply to the final show cause notice, the ERC concluded the following:

1. *The institution has appointed only one teaching faculty of Fine Arts, music and Physical Education whereas there is the requirement of two teaching faculty each for Fine Arts, Music and Physical Education.*
2. *The several teaching faculties appointed by the institution is matching with B.Ed., M.Ed. and D.El.Ed. programme each other's which is not acceptable as per NCTE Regulations.*
3. *The total land area is 3724 sqmts as per CLU which is less than for running four-unit B.Ed. course, one unit D.El.Ed. course and one unit M.Ed. course.*
4. *The total built up area is 4774.56 sqmt for running four-unit B.Ed. course, one unit D.El.Ed. course and one unit M.Ed. course which is less than the requirement under NCTE Regulations amended from time to time.*
5. *The institution has not submitted approved Building Plan with course wise earmarked area for proposed course and existing course.*
6. *The institution has not submitted latest NEC issued by the Competent Government Authority.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. M.Ed. and D.El.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

8. **NOW THEREFORE**, in term of above decision of ERC, the recognition granted to **Dev Sangha Institute of Professional Studies and Educational Research**, Po – Dev sangha – Bompas town, District – Deoghar, Jharkhand-814114 for running B.Ed., B.Ed. Addl., M.Ed. and D.El.Ed. Programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

9. Further the institution and affiliating body are hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government"

10. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
