WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, **Adhir Saraswati College of Education**, Plot No.-711, 712, Vill-Natna, P.O.- Natnapattabuka, Tehsil/Taluka- 87 Pattabukahuda, Town/City-Karimpur, Dist - Nadia, West Bengal-741122 was granted recognition for D.El.Ed. of two years duration with an intake of 100 vide ERC Order No. ERC/303.8/ERCAPP4259/D.El.Ed./2022/65353 dated 08.04.2022 followed by recognition for B.Ed. of two years duration with an intake of 100 vide ERC Order No. ERC/303.8/ERCAPP4274/B.Ed./2022/65346 dated 08.04.2022, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, the institution has submitted representation for Shifting of Premises and Change of Name. The matter was placed before ERC in its 339th meeting of the ERC held on 13.02.2024 and the committee decided as under:-

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

The Committee decided to constitute on-line Visiting Team for inspection of infrastructural & instructional facilities etc. of the institution for shifting of premises and to check the adherence of compliance of conditions stipulated under NCTE Regulation."

4. **AND WHEREAS**, the VT has been conducted on 18.06.2024. The matter was considered by the ERC in its 358th meeting of the ERC held on 06.02.2025 and the committee decided as under:-

"The original file of the institution alongwith other related documents, NCTE Act, 1993, VT report of the institution, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC:-

1. *Particulars namely authorized person namely Sh Adhir Pal and Sh Arun Dash is not presented at the time of the inspection.*
2. *Multipurpose Hall 92.61 Sq mtrs Library-cum Reading Room-81.90 sq. mtrs not as per Approved Map which is less than NCTE Regulation.*
3. *Building is under construction and not yet ready. Multipurpose Hall- Not properly furnished, No projector.*
4. *Library:- No sitting arrangement, size is small. Lab 1 – Not furnished /no equipment, Size is small. Lab 2 not furnished /no equipment, Size is small. Lab 3 – not furnished, size is small, Playground – not maintained.*

5. *FDRS in respect of Endowment and Reserved funds is required to be submitted.*
6. *Copy of affiliation order from the affiliating University is required to be submitted.*
7. *List of practice teaching school with distance from the institution indicating of students deputed to each institution is required.*
8. *Latest list of faculty members approved by the affiliating university and their appointment in the institution specifically mentioning their qualification with subjects, nature of appointment (Regular/Contract/any other) pay scale, total emoluments etc is required.*
9. *Bank Statement for salary of last three months is required.*
10. *A copy of affiliation order issued by the concerned affiliating body is required. .*
11. *List of Equipment's and materials available for different curriculum Area is required.*
12. *Details of No. of Books/Journals/Periodicals is required.*
13. *The copy of BCC is required issued from competent authority.*

In view of the above, the Committee has decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 21 days from the date of issue of show cause notice on the above deficiencies through online portal before passing rejection order on the above grounds".

6. **Accordingly,** Show Cause Notice dated 21.02.2025 was issued to the institution.

7. The institution has submitted its reply of Show Cause Notice dated 21.02.2025. The matter was considered by the ERC in its 367th meeting of the ERC held on 04.06.2025 and the committee decided as under:-

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time, applications for shifting of premises and change of name of the institution, VT Report, reply of Show Cause Notice after Inspection were placed before the Eastern Regional Committee and the Committee observed the following: -

- *The institution has submitted an application for shifting of the premises and change of name of the institution.*
- *The institution has submitted reply of SCN post inspection for shifting of premises.*

After carefully observing the relevant documents, the committee decided that The institution be permitted to change the name of institution from "Adhir Saraswati College of Education to "eduversia" and permitted the shifting of the institution from " Plot No.-711, 712, Village - Natna, P.O.- Natna Pattabuka, Tehsil/Taluka- 87 Pattabukahuda, Town/City - Karimpur, Dist - Nadia, West Bengal-741122" to " Plot No. 2736, 2737, 2757,2760,2761, Village- Birpur, Post – Birpur, PS- Nakashipara, District- Nadia, West Bengal-741126 for running B.Ed. & D.El.Ed. Programmes".

6. **NOW THEREFORE,** in terms of the above decision of ERC, change of name of the institution from "Adhir Saraswati College of Education to eduversia" and shifting of the institution from " Plot No.-711, 712, Village - Natna, P.O.- Natna Pattabuka, Tehsil/Taluka- 87 Pattabukahuda, Town/City - Karimpur, Dist - Nadia, West Bengal-741122" to " Plot No. 2736, 2737, 2757,2760,2761, Village- Birpur, Post – Birpur, PS-Nakashipara, District-
