WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, **K.K.M. College, Pakur, P.O.- Pakur, Dist.- Pakur, Jharkhand-816107** was granted recognition for B.Ed. programme of one year duration with an annual intake of 100 (one hundred) seats vide Order No. ERC/7-60.6.4/2005/106-113 dated 06.09.2005 from the academic session 2005-2006 followed by the Revised Recognition Order vide Order No. ERC/7-191.12.13/APE00436/B.Ed./2015/34584 dated 07.08.2015 with an annual intake of 100 students (two basic units) as per NCTE Regulations, 2014.

2. **AND WHEREAS**, a complaint letter no. NCTE-C/PG011/88/2023-Complaint Section-HQ/121408 dated 12.09.2023 was received from NCTE (HQ) thereby requesting for strict action against the institution.

3. **AND WHEREAS**, the aforesaid complaint was considered by ERC in its 333 (Virtual) meeting held on 27th September 2023, and the committee decided that show cause notice under section 17(1) of NCTE Act, 1993 be issued to the institution on the following grounds:-

"The original file of the institution and the letter No. NCTE-C/PG011/88/2023- Complaint Section-HQ/121408 dated 12.09.2023 received from NCTE (HQ), other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee decided that to seek the following document from the institution:

- Latest faculty duly approved by the affiliating body concerned to be submitted.
- Uploading of documents on the web-site of the institutions as required under clause 7(14) of the NCTE Regulations, 2014 as amended from time to time.
- Copy of renewed FDRs in respect of Endowment & Reserve Fund along Form "A" duly signed by the Manager of the issuing bank concerned.
- Fire Safety Certificate, Building Safety Certificate, Land Use Certificate and Non Encumbrance Certificate issued by the Competent Government Authority to be submitted.
- Building Plan with course demarcation and Building Completion Certificate duly approved by the Competent Government Authority to be submitted.
- Salary statement for payment of salary paid to the faculty appointed in the institution through Bank duly certificated by the disbursing bank for the last 6 months is required to be submitted.

In view of above, the Committee also decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice."

4. **Accordingly**, Show Cause Notice dated 17.10.2023 was issued to the institution.

5. **AND WHEREAS**, reply dated 08.1.2024 has been received from the institution. The matter was placed before 360th meeting of ERC held on 03.03.2025 and the Committee decided as under:

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Reply of First Show Cause Notice, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC:

- 1. As per teaching staff profile, the institution has appointed one principal and five lecturers only for two units of B.Ed Course which is less than NCTE Regulation. The said teaching staff list is not issued by the Registrar of the concerned University.*
- 2. The institution has submitted a copy FDRs which is already matured on 26.07.2024. Therefore, the institution has to submit a copy of renewed FDRs in respect of Endowment & Reserve Fund along Form "A" duly signed by the Manager of the issuing bank concerned.*
- 3. The institution has not submitted Fire Safety Certificate. Hence the institution is required to submit Fire Safety Certificate issued by the Competent Government Authority.*
- 4. The institution has submit photocopy of Non-Encumbrance Certificate which is not readable Hence the institution is required to submit readable copy latest Encumbrance Certificate issued by competent authority.*
- 5. The institution has submitted Building Plan which is not readable. Hence, the institution is required to submit with earmarked area of Building Plan with running courses duly approved by the Competent Government Authority.*
- 6. The institution has submitted BCC issued by Executive Engineer, Pakur, Jharkhand wherein some columns are blank. Hence the institution is required to submit latest BCC in al respect issued by the competent authority.*
- 7. The institution has not submitted six month bank statement indicating payment of salary paid to the faculty appointed in the institution Hence the institution is required to submit Salary statement for payment of salary paid to the faculty appointed in the institution through Bank duly certificated by the disbursing bank for the last 6 months.*

In view of above, the Committee has decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution before withdrawal of recognition to submit reply within 15 days from the date of issue of show cause notice."

6. Accordingly, Final Show Cause Notice dated 18.03.2025 was issued to the institution.

7. **AND WHEREAS**, the institution has submitted its reply dt. 01.04.2025 received in ERC office on 16.04.2025. The matter was placed before ERC in its 367th Meeting held on 04th June, 2025 and committee decide that:-

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- *The institution has submitted reply to the final show cause notice.*

After carefully observing the reply to the final show cause notice, the ERC concluded the following:

1. *The institution has submitted faculty list of I+4 issued by the Registrar, S.K.M. University, Dumka which is not in the prescribed format and is incomplete.*
2. *The institution has submitted Building Plan which is not readable.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order."

6. **NOW THEREFORE**, in term of above decision of ERC, the recognition granted tor **K.K.M. College, Pakur, P.O.- Pakur, Dist.- Pakur, Jharkhand-816107** for running B.Ed. Programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

8. Further the institution and affiliating body are hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
