WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Dinabandhu B.Ed. College, Plot No. 438, 451, Vill.-Ragunathpur, Po.-Paligram, Tehsil/Taluka-Mangalkote, Dist.-Bardhaman, West Bengal-713128 was granted recognition for B.Ed. programme of one year duration with an annual intake of 100 seats from the academic session 2012-2013 vide order No.ERC/7-139.6.5/NCTE/B.Ed./2012/3392 dated 19.08.2012, followed by revised recognition for B.Ed. programme of two year duration with an annual intake of 100 students (two basic units) from the academic session 2015-2016 vide order No. F.ERC/NCTE/(ERCAPP687)B.Ed. (Revised Order)/2015/32607 dated 31.05.2015 as per NCTE Regulations, 2014.

2. AND WHEREAS, a complaint letter vide no. Ref.No. BSAEU/RO/291/2023 dated 22.05.2023 was received from the Registrar Baba Saheb Ambedkar Education University (BSAEU) in the office of ERC against the existing teacher training institutions regarding short comings/deficiencies prevailing in the institutions.

3. AND WHEREAS, the aforesaid complaint was considered by ERC in its 328th (Virtual) meeting held on 12th June, 2023, and the committee decided that show cause notice under section 17 of NCTE Act, 1993 be issued to the institution on the following grounds:-

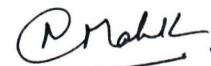
“The original file of the institution and the letter No. BSAEU/RO/291/2023 dated 22.05.2023 received from the Registrar Baba Saheb Ambedkar Education University (BSAEU), other related documents, NCTE Act 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee decided that:

- *The institution is required to submit a valid Fire Safety Certificate issued by the Competent Govt. Authority.*

In view of above, the Committee also decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice.”

4. AND WHEREAS, as per decision of ERC, a Show Cause Notice dated 23.06.2023 was issued to the institution. The institution has not submitted the reply of Show Cause Notice.

5. AND WHEREAS, the matter was considered by ERC in its 332nd (Virtual) meeting of ERC held on 30th August, 2023 and the committee decided the following:

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:

- *The institution has not submitted the valid Fire Safety Certificate issued by the Competent Govt. Authority.*

In view of above, the Committee also decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution before withdrawal of recognition to submit reply within 07 days from the date of issue of show cause notice.

Accordingly, Final Show Cause Notice was issued to the institution dated 18.09.2023.

06. **AND WHEREAS**, the representation received in ERC office 25.09.2023 was considered by the ERC in its 333rd (Virtual) meeting held on 27.09.2023 and the Committee decided as under:-

The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered was considered by ERC and the Committee observed that:

- *The institution has not submitted the valid Fire Safety Certificate issued by the competent government authority.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

07. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to Dinabandhu B.Ed. College, Plot No. 438, 451, Vill.-Ragunathpur, Po.-Paligram, Tehsil/Taluka-Mangalkote, Dist.-Bardhaman, West Bengal-713128 for running B.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

08. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

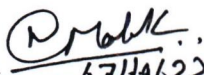

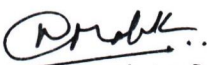
