WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to **Mirza Noor Mahammad College of Education, Plot No-147, 154, 153, 147/255, 147/257, Vill/ PO- Lutunia, Tehsil/Taluka-Sabang, Town/City-Kharagpur, Dist.- Midnapore, West Bengal- 721166** for conducting D.El.Ed. programme of two year duration with an annual intake of 50 seats vide ERC order No. ERC/7-140.6.28/NCTE/D.El.Ed./2012/13879 dated 31.08.2012, as per NCTE Regulations, 2014 and followed by additional intake of 50 (Existing 50 + Addl. 50= 100) thus making the sum total intake of 100 (two basic units) from the academic session 2017-2018 vide ERC order No. F.No.ER-236.6.42(P-3)/ERCAPP4220/D.El.Ed. (Addl. Intake)/2017/52534 dated 26.04.2017.

2. **AND WHEREAS**, a complaint letter dated 22.11.2022 was received in the office of ERC against the existing teacher training institution regarding short comings/deficiencies of faculty, uploading of information on web-site, payment of salary to faculty and infrastructure & instructional facilities etc. as required under NCTE Regulations, 2014.

3. **AND WHEREAS** the aforesaid complaint was considered by ERC in its 316th (Virtual) meeting of ERC held on 20th December, 2022 original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:

“A complaint dated 22.11.2022 has been received from the Registrar of Baba Saheb Ambedkar Education University, Kolkata recommending that the institution be de-recognized by NCTE on the following grounds:

- The institution is imparting B.Ed. programme without appointing the required number of faculty as per NCTE Regulations, 2014.*
- The staff is not being paid salaries as per UGC/Central/State Scale.*

In view of above, the Committee decided Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 21 days from the date of issue of show cause notice before withdrawal of recognition on the following grounds:

- The institution is required to submit the latest list of teaching faculty duly approved by the affiliating body/university along with affidavit, testimonials, service certificate, marks card etc. in respect of B.Ed., D.El.Ed. & D.El.Ed. (Add.) programme.*

- *Salary statement for payment of salary paid to the faculty appointed in the institution through Bank duly certificated by the disbursing bank for the last 6 months is required to be submitted.*

4. **AND WHEREAS**, as per decision of ERC, a Show Cause Notice dated 27.12.2022 was issued to the institution. The institution has not submitted the reply in response of Show Cause Notice.

5. **AND WHEREAS**, the matter was considered by ERC in its 332nd (Virtual) meeting of ERC held on 30th August, 2023 and the committee decided that Final Show Cause Notice under section 17(1) of NCTE Act, 1993 be issued to the institution before withdrawal of recognition on the following grounds:

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:

- *The institution has not submitted the reply of Show Cause Notice dated 27.12.2022 issued to it.*

In view of above, the Committee also decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution before withdrawal of recognition to submit reply within 07 days from the date of issue of show cause notice.”

Accordingly, Final SCN dated 05.09.2023 was issued to the institution.

6. **AND WHEREAS**, the institution has submitted reply dated 20.07.2023 in respect of B.Ed. course only. However, the institution has not submitted reply of SCN for D.El.Ed programme. The matter was placed before 360th meeting of ERC and the committee decided as under:

The original file of the institution alongwith other related documents, NCTE Act, 1993, Reply of Final Show Cause Notice, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC:-

1. *The institution has not submitted the latest list of teaching faculty duly approved by the affiliating body along with affidavits, testimonials, service certificates, marks card etc. in respect of D.El.Ed. & D.El.Ed. (Add.) programme*
2. *The institution has not submitted salary statement for payment of salary paid to the faculty appointed in the institution through Bank duly certificated by the disbursing bank for the last 6 months*

Hence, Committee has decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order

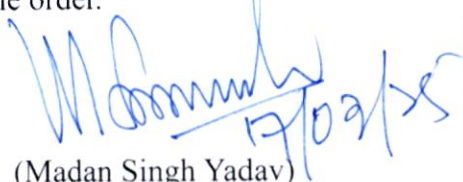

7. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to **Mirza Noor Mahammad College of Education, Plot No-147, 154, 158, 147/255, 147/257, Vill/ PO- Lutunia, Tehsil/Taluka-Sabang, Town/City-Kharagpur, Dist.-Midnapore, West Bengal- 721166** for running B.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

10. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
