Change of Premises of the Institution

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, the recognition was granted to **Model Education College, Plot No. 1027, Vill.-Tasarkata, O.-Barobagan, Tehsil/Taluka-Suri, Town/City-Suri, Dist.-Birbhum, West Bengal-731103** for conducting B.Ed. programme of two year duration with an annual intake of 100 students (Two basic unit) vide Order No. ER-181.6.32/ERCAPP1801/B.Ed./2015/30684 dated 01.03.2015 from the academic session 2015-2016.

2. **AND WHEREAS**, the institution has applied for shifting of premises vide letter dated 10.05.2023.

3. **AND WHEREAS**, the matter was considered by the ERC in its 326th (Virtual) meeting of the ERC held on 23rd May, 2023 and the committee decided as under:-

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:

The Committee considered the application dated 24.09.2022 submitted by the institution for shifting of its premises for running B.Ed. programme and observed that the application of the institution is deficient on the following grounds:

- *The institution has not submitted the Building Safety Certificated issued by the Govt. Competent Authority.*
- *The institution has not submitted the Fire Safety Certificate approved by the Office of the Divisional Fire Officer/Chief Fire Officer or Govt. Competent Authority.*
- *An affidavit in prescribed format on Non-Judicial Stamp Paper of Rs. 100/- attested by Notary Public/Oath Commissioner is not submitted.*
- *A certificate to the effect that the institutional campus, building furniture is disabled friendly as per the persons with disability (PWD) and of the Govt. of India not submitted.*

In view of above, the Committee also decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice."

4. **AND WHEREAS**, the institution has submitted the reply dated 12.06.2023 received in ERC 19.06.2023.

5. **AND WHEREAS**, the matter was considered by the ERC in its 332th (Virtual) meeting of the ERC held on 30th August, 2023 and the committee decided as under:

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:

The Committee decided to constitute on-line Visiting Team for inspection of infrastructural & instructional facilities etc. of the institution for shifting of premises and to check the adherence of compliance of conditions stipulated under NCTE Regulations”.

6. **AND WHEREAS**, VT Repot received in ERC on dated 19.10.2023

7. **AND WHEREAS**, the matter was considered by the ERC in its 336th (Virtual) meeting of the ERC held on 20th December, 2023 and the committee decided as under:-

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:

The VT members has made the following remarks in VTR:

- *The institution does not have proper electric and electronic material in the multipurpose hall.*
- *No adequate equipment is available in all labs in the institution.*
- *No proper playground is there in the institution.*
- *No faculty approval list was presented during the inspection.*
- *The Committee also noted that the institution has not submitted the latest Non-Encumbrance Certificate (NEC) approved by the Govt. Competent Authority.*

In view of above, the Committee decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice”.

Accordingly, Show Cause Notice was issued to the institution on 07.02.2024.

8. **AND WHEREAS**, the institution has submitted reply dated 21.01.2024 received in ERC office on 08.02.2024 on the basis of the minutes of 336th meeting of ERC held on 20th December, 2024.

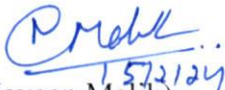
9. **AND WHEREAS**, the matter was considered by the ERC in its 339th (Virtual) meeting of the ERC held on 13.02.2024 and the committee decided as under:-

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:



- *The Committee Considered the report of Visiting Team for shifting of premises and decided to permit the shifting of the institution namely Model Education College from "Plot No-1027, Post Office-Barobagan, Village-Tasarkata, Town/City-Suri, Tehsil/Taluka-Suri, District- Birbhum, State-West Bengal, Pin Code- 731103" to "Plot No. 1010, Mouza-Gobindapur, Vill-Gobindapur, P.O.-Muluk, P.S.-Bolpur, Block-Bolpur, Sriniketan, Tehsil/Taluka-Bolpur, Under Sian-Muluk Gram Panchayat, District-Birbhum, Pin Code-731204, West Bengal" to run B.Ed. Programme". Orders be issued accordingly."*

6. **NOW THEREFORE**, in terms of above decision of ERC, shifting of institution namely Model Education College is hereby permitted from "Plot No-1027, Post Office-Barobagan, Village-Tasarkata, Town/City-Suri, Tehsil/Taluka-Suri, District- Birbhum, State-West Bengal, Pin Code- 731103" to **"Plot No. 1010, Mouza-Gobindapur, Vill-Gobindapur, P.O.-Muluk, P.S.-Bolpur, Block-Bolpur, Sriniketan, Tehsil/Taluka-Bolpur, Under Sian-Muluk Gram Panchayat, District-Birbhum, Pin Code-731204, West Bengal"** to run B.Ed. Programme.
