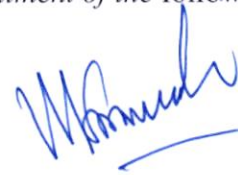
CORRIGENDUM

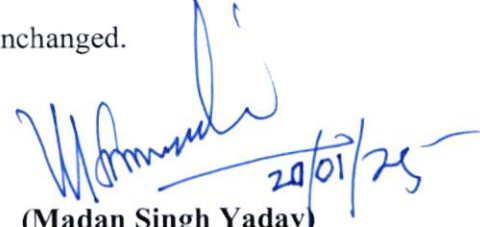
3. The para 4 of the order may be read as under:-
