WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, **Bankim Behari Teachers Training Institute, Plot No- 236, 237, 238, 239, Vill- Markandachak, PO- Bishnupur Bazar, Tehsil/Taluka- Sabong, Town/City- Midnapore, Dist- Midnapore, West Bengal- 721144** was granted recognition for B.Ed. programme of two year duration with an annual intake of 50 students (one basic unit) from the academic session 2016-2017 vide ER-210.6.33/ERCAPP3175/B.Ed./2016/45811 dated 01.05.2016 and additional intake of 50 (Existing 50 intake + Additional 50 intake) total intake of 100 students (two basic units) from the academic session 2018-2019 vide F.No.ER-243.6.15/ID No.-9663/B.Ed.(Addl. Intake) & D.El.Ed.(Addl. Intake)/2017/54726 dated 18.10.2017 as per NCTE Regulations, 2014.

02. AND WHEREAS, two complaints dated 01.09.2023 & 03.10.2023 received from the Registrar of Baba Saheb Ambedkar Education University (BSAEU) in the office of ERC against the existing teacher training institutions regarding short comings/deficiencies prevailing in the institutions.

03. AND WHEREAS, the aforesaid complaint was considered by ERC in its 336th meeting held on 20th December, 2023, and the Committee decided that Show Cause Notice under section 17 of NCTE Act, 1993 be issued to the institution on the following grounds:-

"The original file of the institution alongwith other related documents, two Complaints dated 01.09.2023 & 03.10.2023 received from the Registrar of Baba Saheb Ambedkar Education University (Erstwhile WBUTTEPA), Kolkata, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee noted the following:

- Latest faculty duly approved by the affiliating body concerned to be submitted.
- The institution has not uploaded the essential documents on the website of the institution as required under clause 7(14) of the NCTE Regulations, 2014 as amended from time to time.
- Copy of renewed FDRs in respect of Endowment & Reserve Fund along Form "A" duly signed by the Manager of the issuing bank concerned to be submitted.
- Fire Safety Certificate, Building Safety Certificate, Land Use Certificate and Non-Encumbrance Certificate issued by the Competent Government Authority to be submitted.
- Building Plan with course-wise demarcation and Building Completion Certificate duly approved by the Competent Government Authority to be submitted.
- Salary statement for payment of salary paid to the faculty appointed in the institution through Bank duly certificated by the disbursing bank for the last 6 months is required to be submitted.

In view of the above, the Committee decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice."

04. Accordingly, Show Cause Notice dated 07.02.2024 was issued to the institution

05. **AND WHEREAS**, the institution has submitted reply dated 21.03.2025 received in ERC office on 04.04.2025. The matter was placed before 364th meeting of ERC held on 30th April 2025 and the committee decided as under:

“The original file of the institution alongwith other related documents, NCTE Act, 1993, complaint, Reply of Show Cause Notice, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC:-

1. *The institution has not submitted teaching faculty list in prescribed format.*
2. *The institution has not uploaded the essential documents on the website of the institution as required under clause 7(14) of the NCTE Regulations, 2014 as amended from time to time.*
3. *The institution has not submitted a copy of building Safety Certificate issued by the Competent Government Authority.*
4. *The institution has not submitted building plan with course wise demarcation area .*
5. *The institution has submitted copy of Salary statement for payment of salary paid to the faculty appointed in the institution through Bank certificated by the Punjab National Bank for the last 6 months. Which is not clear.*

In view of above, the Committee has decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution before withdrawal of recognition to submit reply within 15 days from the date of issue of show cause notice.

Further Another complaint letter no. NCTE-C/Pg011/179/2021 received from Complaint Section-HQ dated 20.01.2022 which does not pertain to ERC, NCTE. Hence the same may be forwarded to the affiliating body for further needful in the matter.”

06. **Accordingly**, Final Show Cause Notice dated 08.05.2025 was issued to the institution.

07. **AND WHEREAS**, the institution has submitted reply on 14.05.2025. The matter was placed before 384th meeting of ERC held on 09th – 10th December 2025 and the committee decided as under:

“Decision of ERC:

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- *First SCN was issued to the institution on 07.02.2024 and Final SCN was issued to the institution on 08.05.2025. The institution has submitted reply on 14.05.2025*

After carefully observing the reply to the final show cause notice, the ERC concluded the following:

1. *The institution has not uploaded the essential documents on the website of the institution as required under clause 7(14) of the NCTE Regulations, 2014 as amended from time to time.*
2. *The institution has not submitted copy of Building Safety certificate.*
3. *The institution has submitted a copy of Building plan, which is not readable.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.”

08. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to Bankim Behari Teachers Training Institute, Plot No- 236, 237, 238, 239, Vill- Markandachak, PO- Bishnupur Bazar, Tehsil/Taluka- Sabong, Town/City- Midnapore, Dist- Midnapore, West Bengal- 721144 for running B.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

09. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

10. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
