ORDER

In terms of Section 14/15 of the NCTE Act, 1993 **Parjanya B.Ed. College, Plot No. 1,3,4,5,6, St No. Hirak Road, Vill-Paharpur, P.O. Baliapur, P.O. Baliapur, Tehsil/Taluka-Baliapur, City/Dist-Dhanbad, Jharkhand-828201** was granted recognition for B.Ed. programme of two year duration vide Order No. ERC/7-151.6.13/NCTE/B.Ed./2013/16589 Date 02.03.2013 from the academic session 2018-2019 followed by Revised order No. ERC/NCTE/ERCAPP1124/B.Ed.(Revised Order)2015/31956 Date 23.05.2015 with intake of 100 two basic units from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHEREAS**, the ERC in its 275th meeting held on 30th -31st May & 1st June 2019 decided that recognition granted to the institution for B.Ed. programme be withdrawn u/s17(1) of NCTE Act, 1993 vide Order no.ER-275.14.36/ERCAPP1124/B.Ed/2019/61399 dated 26.08.2019 for the academic session 2020-2021 on certain grounds.

3. **AND WHEREAS**, the institution preferred an appeal before NCTE Appellate Authority against the Withdrawal Order dated 26.08.2019 and the NCTE Appellate Authority in its Order dated 05.12.2019 decided to remand back the case to ERC.

4. **AND WHEREAS**, the above mentioned order dated 05.12.2019 was considered by ERC in its 279th meeting held on 14th - 16th February 2020 and decided that restoration of recognition order of B.Ed. course to be issued. Accordingly, Restoration Order dated 03.03.2020 was issued to the institution.

5. **AND WHEREAS**, a complaint letter vide letter no. NCTE-C/PG011/91/2023-Complaint Section-HQ dated 25.09.2024 has been received from the Complaint Section, NCTE (HQ) alongwith a letter dated 24.06.2023 of the complainant namely Sh. Ram Saroj Kumar Yadav regarding invalidation of PhD degree certificate of Dr. Smriti Negi, Principal of Parjanya B.Ed. College, Paharpur, Balliapur, Dhanbad, Jharkhand.

6. **AND WHEREAS**, the matter was placed before 363rd meeting of ERC-NCTE held on 21st April, 2025, the committee considered the matter and decided as under:-

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Complaint Letter dated 25.09.2024, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC:

- The complainant has submitted an application that the institution has appointed Principal namely; Dr. Smriti Negai, who is not qualified as per NCTE regulation and she has submitted fabricated educational qualification of Ph.D.*

In view of the above, the Committee has decided to issue SCN to the institution with direction to submit its reply to this office within 21 days from the date of issue of the letter. Further copy of the complaint may be forwarded to the affiliating body for providing their comments in the instant matter.

7. **Accordingly**, Show Cause Notice was issued to the institution on 07.05.2025.

8. **AND WHEREAS**, the institution has submitted reply on 28.05.2025. The matter was placed before 384th meeting of ERC held on 09th – 10th December 2025 and the committee decided as under:

“The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- *Show Cause Notice was issued to the institution on 07.05.2025. The institution has accordingly submitted reply on 28.05.2025.*
- *The institution has requested to cancel the appointment of Dr. Smriti Nagi as a Principal and allow them to appoint a new principal following the due procedure and submit the faculty list duly approved by the Registrar of the University concerned as soon as possible.*

After carefully observing the reply to the show cause notice, the ERC concluded the following:

1. *The institution is required to submit latest qualified teaching faculty approved by the affiliating university in prescribed format as mentioned by them.*
2. *The institution is required to submit relevant documents related to appointment of Principal.*

In view of the above, the Committee decided that Final Show Cause be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 7 days from the date of issue of Show Cause Notice on the above deficiencies.”

9. **Accordingly**, Final Show Cause Notice Dated 02.01.2026 was issued to the institution and the institution has submitted the reply accordingly.

10. **AND WHEREAS**, the matter was placed again in ERC in its 394th Meeting held on 01st April, 2026 and committee decided as under:-

Decision of ERC:

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Complaint Letter dated 25.09.2024, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC: -

- *Show Cause Notice dated 07.05.2025 was issued to the institution. Accordingly, the institution has submitted the reply dated 28.05.2025.*
- *Thereafter, the final SCN was issued to the institution on 02.01.2026. Accordingly, the institution has submitted reply.*

After carefully observing the reply of the institution with other related documents, the ERC found deficient on the following grounds.

1. *The institution has appointed teaching faculty i.e one principal and 10 lecturers approved by the Registrar, B.B.M Koyalanchal University Dhanbad, Jharkhand dated 16.12.2025 which is sufficient not for two units as per NCTE Regulations amended from time to time.*

In view of the above, the Committee decided to reduce the intake from two units to one unit from the academic session 2026-2027.

11. **Accordingly**, Revised Order vide No. F.No. ER-394.20/ERCAPP1124 /B.Ed. /JH/2 026/ (73038-73044) Date 20.04.2026 was issued to the institution.

12. **ANDWHEREAS**, the institution has preferred appeal before Appellate Authority, NCTE against the Order dated 02.05.2026 and the Appellate Authority, NCTE decided to remand back the case to ERC and the institution has submitted reply dated 05.06.2026 received in ERC office on 08.06.2026

13. **AND WHEREAS**, the matter was placed again in ERC in its 398th Meeting held on 10-11th June, 2026 and committee decided as under:-

Decision of ERC

"The online file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, Appeal Order passed by the NCTE-HQ, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

1. *The institution was recognized for B.Ed Course of two units*
2. *Show Cause Notice dated 07.05.2025 was issued to the institution. Accordingly, the institution has submitted the reply dated 28.05.2025.*
3. *Thereafter, the final SCN was issued to the institution on 02.01.2026. Accordingly, the institution has submitted reply.*
4. *The institution has appointed teaching faculty i.e one principal and 10 lecturers approved by the Registrar, B.B.M Koyalanchal University Dhanbad, Jharkhand dated 16.12.2025 which is sufficient not for two units as per NCTE Regulations amended from time to time.*
5. *Committee decided to reduce the intake from two units to one unit from the academic session 2026-2027. Accordingly a letter has been issued to the institution on 20.04.2026.*
6. *The institution preferred appeal before Appellate Authority, NCTE-HQ against the order dated 20.04.2026 and the Appellate Authority, NCTE-HQ, passed an order 89-171/E-408635/2026 Appeal/7th Meeting, 2026 APPLERC202615638 Dated 02.05.2026 which is as under:*

"After careful consideration of the Appeal Report, the impugned order, the records available on file, and the submission made by the appellant institution, the Appeal Committee of the council, in exercise of appellate jurisdiction under section 18 of the NCTE Act, 1993, concluded to remand the matter to the Eastern Regional Committee (ERC) for limited factual verification and regulatory reassessment. Accordingly, the impugned order dated 20.04.2026 shall remain kept in abeyance until the ERC takes an appropriate decision after examination of the submission of the appellant institution vis-à-vis the verified substance of the complaint and verification of staff/faculty particular from the affiliating university, strictly in accordance with the provision of NCTE Act, 1993, Rules and the NCTE Regulation, 2014".

7. The institution has submitted reply as per direction of the appeal committee.

After careful examination of the submissions of the appellant institution and the faculty particulars properly verified by the registrar of the affiliating University, the Committee has decided that that the recognition of the institution granted vide order no. ERC/7-151.6.13/NCTE/B.Ed./2013/16589 Date 02.03.2013 be restored. Concerned Affiliating Body be informed accordingly.

14. NOW THEREFORE, recognition granted to the institution viz. **Parjanya B.Ed. College, Plot No. 1,3,4,5,6, St No. Hirak Road, Vill-Paharpur, P.O. Baliapur, P.O.-Baliapur, Tehsil/Taluka-Baliapur, City/Dist-Dhanbad, Jharkhand-828201 (code no. ERCAPP1124)** for conducting B.Ed. Course vide order No. ERC/7-151.6.13/NCTE/B.Ed./2013/16589 Date 02.03.2013 with annual intake of 100 Students (two basic units) is hereby restored.

Also order that a copy of this Order be published in the Official Gazette.
