ORDER

ERC/7-51(ER-51.7.7)/2024/3623/9 dated 10.12.2004 followed by Revised Recognition Order *vide* Order No. F.ERC/NCTE/ERCAPE00722/B.Ed. (Revised Order)/2015/32504 dated 30.05.2015 with an annual intake of 100 (two units) from the academic session 2015-2016.

(ii) **AND WHEREAS**, In terms of Section 14/15 of the NCTE Act, 1993, recognition was granted to **Radha Govind Primary Teacher's Training College**, Behind Ramgarh College, Ramgarh Cantt., Dist. Hazaribagh, Jharkhand-829122. for conducting **D.El.Ed.** programme of two year duration *vide* Order No. ERC/7-85.6 (I).1/2008/10710 dated 09.04.2008 with an annual intake of 50 from the academic session 2008-2009.

(iii) **AND WHEREAS**, In terms of Section 14/15 of the NCTE Act, 1993, recognition was granted to **Radha Govind Primary Teacher's Training (M.Ed.) College**, Behind Ramgarh College, Ramgarh Cantt., Dist. Hazaribagh, Jharkhand-829122 for conducting M.Ed. programme of two year duration *vide* Order No. F. ERC/NCTE/APE00794/M.Ed.(Revised Order)/2015/32681 dated 31.05.2015 with an annual intake of 50 from the academic session 2015-2016.

2. **AND WHEREAS**, the institution has submitted application dated. 23.09.2025 for shifting of its premises for its B.Ed. , D.El.Ed. & M.Ed. Programme dated 23.09.2025 which has been received in ERC office on 24.09.2025. The matter was placed before 379th meeting of ERC held on 30.09.2025 and the committee decided as under:

VT be constituted in order to ascertain and scrutinize all the essential documents such as land documents, building plan, CLU, BCC, Non-Encumbrance Certificate along with other required documents in original and verify

its authenticity with reference to NCTE Regulations 2014 and mention the status/position of these documents along with deficiencies, if any

In addition, the VT shall also verify the infrastructure and instructional facilities created by the institution so as to assess its preparedness for running the course as per NCTE Regulations 2014."

3. **Accordingly**, As per the direction of ERC, Inspection of the institution was conducted on 01.11.2025.
