WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Sahibganj College, Sahibganj, Post - Sahibganj, District.- Sahibganj, Jharkhand-816109 was granted recognition for B.Ed. programme of one year duration with an annual intake of 100 (one hundred) seats vide Order No. ERC/7-59.11.1/2005/2733 dated 12.08.2005 from the academic session 2006-2007 followed by Revised Recognition order vide Order No ERC/7-191.12.2/APE00434/B.Ed./2015/34586 dated 07.08.2015 with an annual intake of 100 students (two basic units) as per NCTE Regulations, 2014.

2. AND WHEREAS, a complaint letter no. NCTE-C/PG011/88/2023-Complaint Section-HQ/121408 dated 12.09.2023 was forwarded from NCTE (HQ) requesting therein for strict action against the institution.

3. AND WHEREAS, the aforesaid complaint was considered by ERC in its 333rd (Virtual) meeting held on 27th September, 2023, and the committee decided that show cause notice under section 17(1) of NCTE Act, 1993 be issued to the institution on the following grounds:-

“The original file of the institution and the letter No. NCTE-C/PG011/88/2023-Complaint Section-HQ/121408 dated 12.09.2023 received from NCTE (HQ), other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee decided that to seek the following document from the institution:

- Latest faculty duly approved by the affiliating body concerned to be submitted.
- Uploading of documents on the web-site of the institutions as required under clause 7(14) of the NCTE Regulations, 2014 as amended from time to time.
- Copy of renewed FDRs in respect of Endowment & Reserve Fund along Form “A” duly signed by the Manager of the issuing bank concerned.
- Fire Safety Certificate, Building Safety Certificate, Land Use Certificate and Non Encumbrance Certificate issued by the Competent Government Authority to be submitted.

- *Building Plan with course demarcation and Building Completion Certificate duly approved by the Competent Government Authority to be submitted.*
- *Salary statement for payment of salary paid to the faculty appointed in the institution through Bank duly certificated by the disbursing bank for the last 6 months is required to be submitted.*

In view of above, the Committee also decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice.”

4. Accordingly, Show Cause Notice 17.10.2023 was issued to the institution.

5. **AND WHEREAS**, the institution has not submitted reply to SCN within specific time. The matter was considered by ERC in its 356th meeting held on 10 January 2025 and the committee decided as under:

“The original file of the institution and the letter No. NCTE-C/PG011/88/2023-Complaint Section-HQ/121408 dated 12.09.2023 received from NCTE (HQ), other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee decided that to seek the following document from the institution:

The First Show Cause Notice was issued to the institution vide dated 17.10.2023 with a direction to submit reply within 15 days, on the following deficiencies, but the institution has not submitted its reply within specific time.

- *Latest faculty duly approved by the affiliating body concerned to be submitted.*
- *Uploading of documents on the web-site of the institutions as required under clause 7(14) of the NCTE Regulations, 2014 as amended from time to time.*
- *Copy of renewed FDRs in respect of Endowment & Reserve Fund along Form “A” duly signed by the Manager of the issuing bank concerned.*
- *Fire Safety Certificate, Building Safety Certificate, Land Use Certificate and Non Encumbrance Certificate issued by the Competent Government Authority to be submitted.*
- *Building Plan with course demarcation and Building Completion Certificate duly approved by the Competent Government Authority to be submitted.*
- *Salary statement for payment of salary paid to the faculty appointed in the institution through Bank duly certificated by the disbursing bank for the last 6 months is required to be submitted.*

In view of above, the Committee also decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice."

5. Accordingly, Final Show Cause dated 22.01.2025 was issued to the institution.

6. AND WHEREAS, the institution has submitted reply dated 14.2.2024 received in ERC-office on 21.02.2025. The matter was placed before 360th meeting of ERC held on 03.03.2025 and the committee decided as under:

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Reply of Final Show Cause Notice, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC:-

- 1. The institution has submitted approved teaching faculty list i.e. 1 principal and 10 lecturers for two units of B.Ed which is less than NCTE Regulation. Course, However the said faculty list is not in prescribed format.*
- 2. The Course wise teaching faculty is not submitted by the institution.*
- 3. The institution has not uploaded documents on the web-site of the institutions as required under clause 7(14) of the NCTE Regulations, 2014.*
- 4. The Institution has not submitted copy of the Fire Safety Certificate issued by the Competent Government Authority.*
- 5. The Institution has submitted copy of Building Safety Certificate issued by the Principal of the college, which is not a competent authority.*
- 6. The Institution has submitted copy of Land Use Certificate issued by the Principal of college, which is not a competent authority.*
- 7. The Institution has submitted copy of Non-Encumbrance Certificate issued by the Principal of the college, which is not competent authority.*
- 8. The Institution has submitted copy of Building Plan which is not readable.*
- 9. The Institution has submitted copy of Building Completion Certificate which is not readable. However, some columns are blank.*
- 10. The Institution has not submitted copy of Salary statement for payment of salary paid to the faculty appointed in the institution through Bank duly certificated by the disbursing bank for the last 6 months.*

Hence, the Committee has decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of the academic session next following the date of communication of withdrawal order."

7. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to **Sahibganj College, Sahibganj, Post - Sahibganj, District.- Sahibganj, Jharkhand-816109** for running B.Ed. programme is hereby **withdrawn** with effect from the end of academic session next following the date communication of withdrawal order.

8. Further, the institution and affiliating body are hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

9. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
