WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, **Santhal Pargana College, Dumka, Jharkhand-814101** was granted recognition for B.Ed. programme of one year duration with an annual intake of 100 (one hundred) seats vide Order No. ERC/7-59.6.1/2005/2745 dated 12.08.2005 from the academic session **2005-2006** followed by restoration recognition vide Order No ERC/7-191.12.4/APE00435/2015/34583 dated 07.08.2015 with an annual intake of 100 students (two basic units) as per NCTE Regulations, 2014.

2. **AND WHEREAS**, a complaint letter vide no. NCTE-C/PG011/88/2023-Complaint Section-HQ/121408 dated 12.09.2023 was received from NCTE (HQ) thereby forwarding the complaint dated 04.07.2023 requesting for strict action against the institution.

3. **AND WHEREAS**, the aforesaid complaint was considered by ERC in its 333rd (Virtual) meeting held on 27th September, 2023, and the committee decided that show cause notice under section 17(1) of NCTE Act, 1993 be issued to the institution on the following grounds:-

"The original file of the institution and the letter No. NCTE-C/PG011/88/2023-Complaint Section-HQ/121408 dated 12.09.2023 received from NCTE (HQ), other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee decided that to seek the following document from the institution:

- Latest faculty duly approved by the affiliating body concerned to be submitted.
- Uploading of documents on the web-site of the institutions as required under clause 7(14) of the NCTE Regulations, 2014 as amended from time to time.
- Copy of renewed FDRs in respect of Endowment & Reserve Fund along Form "A" duly signed by the Manager of the issuing bank concerned.
- Fire Safety Certificate, Building Safety Certificate, Land Use Certificate and Non Encumbrance Certificate issued by the Competent Government Authority to be submitted.
- Building Plan with course demarcation and Building Completion Certificate duly approved by the Competent Government Authority to be submitted.
- Salary statement for payment of salary paid to the faculty appointed in the institution through Bank duly certificated by the disbursing bank for the last 6 months is required to be submitted.

In view of above, the Committee also decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice."

4. **Accordingly**, Show Cause Notice dated 17.10.2023 was issued to the institution and the institution has submitted reply dated 11.11.2023 received in ERC office on 22.11.2023.

5. **AND WHEREAS**, the matter was placed in ERC in its 360th Meeting held on 360th Meeting held on 22th November, 2023 and committee decided to issue Final Show Cause Notice dated 18.03.2025 and the institution has submitted the reply dated 30.03.2025 received in ERC office on 09.04.2025.

6. **AND WHEREAS**, the matter was placed again in ERC in its 398th Meeting held on 10-11th June, 2026 and committee decided as under:-

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules,

Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- *First SCN was issued to the institution on 17.10.2023. Accordingly the institution has submitted the reply dated 11.11.2023 received in ERC office on 22.11.2023.*
- *Final SCN was issued to the institution on 18.03.2025. Accordingly, the institution has submitted the reply dated 30.03.2025 received in ERC office on 09.04.2025.*

After carefully observing the reply to Final SCN along with other related documents, the ERC concluded the following:-

1. *The faculty particulars have not been provided in the prescribed proforma.*
2. *The Principal and other faculty are not qualified as per NCTE norms.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

7. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted **Santhal Pargana College**, Dumka, Jharkhand-814101 for running B.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

9. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
