ORDER

Change of premises of the Institution

WHEREAS, in terms of Section 14(3)(a) of the NCTE Act, 1993, recognition was Granted to District Institute of Education & Training (DIET), Tathangchen, Education Deptt, Govt. of Sikkim, PO-Raj Bhawan, Gangtok, Sikkim-737103 for conducting D.El.Ed. programme of two year duration with an annual intake of 50 students for (one basic unit) vide Order No. ERC/7-36(ER-36.4.6)/2003/1329(7) dated 04.07.2003 from the academic session 2003-2004 as per NCTE Regulations, 2014.

2. **AND WHEREAS**, the institution has submitted an application for shifting of premises received in ERC office on dated 10.07.2023.

3. **AND WHEREAS**, the matter was considered by ERC in its 331st (Virtual) meeting of ERC held on 26th July, 2023 and the committee decided that Show Cause Notice under section 17 of NCTE Act, 1993 be issued to the institution on the following grounds:

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

The Committee considered the request dated 10.07.2023 made by the institution for shifting its premises and noted the following:

- *The institution has not submitted the certified registered land documents issued by the Registering Authority or civil authority concerned.*
- *The institution has not submitted site plan.*
- *The Building Plan submitted by the institution is not readable. The institution is required to submit the readable approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area and the measurements of the Multi-purpose Hall as well as the other infrastructural facilities such as class rooms etc.*
- *The institution has not submitted the latest Non-Encumbrance certificate issued by the Competent Authority indicating that the land is free from all encumbrances.*
- *The institution has not submitted the Building Safety Certificate issued by the Competent Government Authority.*
- *The institution has not submitted the Fire Safety Certificate issued by the Competent Government Authority.*
- *The institution has not submitted a certificate to the effect that the institutional campus, building furniture is disabled friendly as per the persons with disability (PWD) and of the Govt. of India not submitted.*

In view of above, the Committee also decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice.



4. **AND WHEREAS**, the institution has submitted the reply e-mail dated 19.08.2023 received in ERC 22.08.2023.

5. **AND WHEREAS**, the matter was considered by the ERC in its 332th (Virtual) meeting of the ERC held on 30th August, 2023 and the committee decided as under:

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the committee observed that:

The Committee decided to constitute on-line Visiting Team for inspection of infrastructural & instructional facilities etc. of the institution for shifting of premises and to check the adherence of compliance of conditions stipulated under NCTE Regulations.

6. **ANDE WHERAS**, VT Report received in ERC on dated 19.10.2023

7. **AND WHEREAS**, the matter was considered by the ERC in its 336th (Virtual) meeting of the ERC held on 20th December, 2023 and the committee decided as under:.

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:

The VT members has made the following remarks in VTR:

- *Lift, Ramp and Accessible Toilet are not available in the institution.*
- *The playground is not developed properly in the institution.*
- *Library, Multipurpose Hall and Labs are not set according to norm. Also, the size of the hall seems to be smaller than required.*
- *The Committee also noted that Khata No doesn't match in Land Use Certificate (CLU), Non-Encumbrance Certificate and Building Plan etc.*

In view of above, the Committee decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice.”

8. **AND WHEREAS**, the institution has submitted reply dated 19.01.2024 received in ERC office on 01.02.2024 on the basis of the minutes of 336th meeting of ERC 20th December, 2024.

9. **AND WHEREAS**, the matter was considered by ERC in its 339th (Virtual) meeting of ERC held on 13.02.2024 and the committee decided as under:-

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:



- *The Committee Considered the report of Visiting Team for shifting of premises and decided to permit the shifting of the institution namely District Institute of Education & Training (DIET) from "Tathangchen, Education Department, Govt. of Sikkim, P.O.-Raj Bhawan, Gangtok, Sikkim-737103" to "Lower Burtuk, Near Helipad, Sikkim-737101" to run D.El.Ed. Programme. Orders be issued accordingly."*

10. **NOW THEREFORE**, in terms of above decision of ERC, shifting of institution namely **District Institute of Education & Training (DIET)** from **"Tathangchen, Education Department, Govt. of Sikkim, P.O.-Raj Bhawan, Gangtok, Sikkim-737103"** to **"Lower Burtuk, Near Helipad, Sikkim-737101"** is hereby permitted to run D.El.Ed. Programme.
