ORDER

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, **Tetri Chandravansi College of Education**, Plot No. 288, 370,550 Street No.- Pindra, Vill- Pindra, Post- okhargara, Tehsil/Taluka-Meral Town/City- Garhwa, Distt- Garhwa, Jharkhand-822114 were granted recognition for the following programme:-

- i. **B.Ed.:-** F.No. ERC/7-79.6(I).25/2007/9405 dated 11.09.2007 with intake of 100 students followed by **Revised Order** ERC/NCTE/APE00767/B.Ed.(Revised Order)/2015/32687 dated 31.05.2015 with intake of 2 units 100 students from academic session 2015-2016.
- ii. **M.Ed.:-** F.No.226.6.29/ERCAPP3717/M.Ed./2016/50716 dated 29.12.2016 with intake of 50 students from academic session 2017-2018.

2. **AND WHEREAS**, the institution has submitted an application/letter dated 29/09/2023 for shifting of institution along with documents and D.D for sum of Rs. 1,77,000/- for shifting of premises to **Nawadihkala, Plot No.800, 801, Khata No.54, 70, Bishrampur, Palamu(Jharkhand)-822132**.

3. **AND WHEREAS**, the matter was placed before ERC in its 336th meeting ERC held on 20.12.2023 and Committee decided that Show Cause Notice under section 17 of NCTE Act, 1993 be issued to the institution on the following grounds:

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee noted the following:

- *The size of classrooms and the multipurpose hall in the building plan are not legible. The built-up area is not earmarked for the teacher education programme.*
- *The fire safety certificate submitted by the institution is not reflected online in the Jharkhand fire Services.*

In view of the above, the Committee decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice."

4. **Accordingly**, Show cause notice dated 12.02.2024 was issued to the institution. The institution has submitted the reply dated 27.02.2024 on behalf on 336th Meeting minutes uploaded on NCTE-ERC Portal.

5. **ANDWHEREAS**, the matter was placed again in ERC in its 339th Meeting held on 13.02.2024 and committee decided as under:-

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

The Committee decided to constitute on-line Visiting Team for inspection of infrastructural & instructional facilities etc. of the institution for shifting of premises and to check the adherence of compliance of conditions stipulated under NCTE Regulations.

6. Accordingly, VT was conducted on 02.05.2024. The matter was placed before ERC in its 387th Meeting held on 16th January, 2026 and committee decided as under:-

“The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, Inspection Report for shifting of premises, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following:

- *As per decision of ERC, Inspection was made.*

After carefully observing the online application form, VT report along with other related documents, the ERC found the following:

1. *The seating capacity in the computer lab is lesser than the required sitting capacity and also not upto the mark.*
2. *The Public announcement system for the multi-purpose hall was not available in the institution.*
3. *Ramp and lift were not shown to us.*
4. *Boundary wall for the said course with respect to the institute/college was not shown despite of repeated requests.*

Hence, the committee decided that the show cause notice be issued to the institution to submit the reply through the portal on deficiencies mentioned above within 07 days from the date of issue of the show cause notice.

7. AND WHEREAS, The institution has submitted the reply dated 31.01.2026 on behalf of ERC 387th Meeting Held on 16th January, 2026. The matter was placed again in 390th Meeting held on 09th February, 2026 and committee decided as under:-

Decision of ERC:

“The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, Application of Shifting of Premises, VT Report, Reply of SCN post inspection, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee decided the following: -

Shifting of premises of Tetri Chandravansi College of Education, Plot No. - 288, 550, 370, Street No. - Pindra, Vill - Pindra, Po - Okhargara, Tehsil/Taluka - Meral, Town/City - Garhwa, Distt - Garhwa, Jharkhand – 822114(old) to Nawadihkala, Plot No. 800, 801, Khata No. 54, 70, Bishrampur, Palamu, Jharkhand-822132 (new) is permitted in respect of all the three courses namely B.Ed., M.Ed. & D.El.Ed.

Accordingly, A shifting of premises order dated 20.02.2026 was issued to the institution.

8. AND WHEREAS, the institution has submitted an representation dated 17.02.2026 received in ERC office on 24.02.2026 along with documents regarding Change of examining body for the courses B.Ed. and M.Ed. as “The Ramchandra Chandravansi University, Bishrampur”.

9. NOW THEREFORE, the matter was placed before ERC in its 392th Meeting held on 26th February, 2026 and committee decided as under:-

Decision of ERC:

The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, application for change for affiliating body, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following:

- The institution is recognized for B.Ed programme vide F.No. ERC/7-79.6(1).25/2007/9405 dated 11.09.2007 with intake of 100 students followed by Revised Order ERC/NCTE/APE00767/B.Ed.(Revised Order)/2015132687 dated 31.05.2015 with intake of 2 units i.e. 100 students from academic session 2015-2016.
- The institution is also recognized for M.Ed programme vide F.No.226.6.29/ERCAPP3717/M.Ed./2016/50716 dated 29.12.2016 with intake of 50 students from academic session 2017-2018.
- The institution has submitted representation dated 17.02.2026 received in ERC office on 24.02.2026 along with relevant documents for changing of affiliating body for B.Ed course and M.Ed course as The Ramchandra Chandravansi University, Bishrampur

After carefully observing the request of the institution along with other related documents, the ERC decided to permit change of the affiliating body/examining body from Nilamber Pitamber University to The Ramchandra Chandravansi University, Bishrampur, Palamu, Jharkhand-822132 in respect of B.Ed. & M.Ed courses.

10. Decision of the committee is conveyed for information and further necessary action.
