WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, **Mohan Shakuntala Teachers' Training College**, Vill:-Madhepura, Street/Road:-Ward No-04, Taluka/Mandal:-Madhepura, Town/City:-Madhepura, Dist:-Madhepura, Bihar- 852113 was granted recognition for B.Ed. programme of two year duration with an annual intake of 50 students (one basic units) from the academic session 2018-2019 vide order No. F.No.ERC/248.6.4/B.Ed. & D.El.Ed./2017/55825 date 31.01.2018, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, a Letter Vide Letter no. NCTE-CDN016(13)/18/2018-CDN-HQ Dated 02.08.2018 received from NCTE HQ with a direction to issue show cause notice to the institution which have been recognized without NET qualified teachers.

3. **AND WHEREAS**, the aforesaid matter was considered by ERC in its 284th meeting held on 17th - 18th September, 2020 and the Committee decided to issue Show Cause Notice.. Accordingly, Show Cause Notice dated 28.09.2020 was issued to the institution. The institution has not submitted the reply of Show cause notice which was issued to the institution.

4. **AND WHEREAS**, the matter was placed again in ERC in its 303rd Meeting held on 24th March, 2022 and committee decided to issue Final Show Cause Notice. Accordingly, Final Show Cause notice dated 09.04.2022 was issued to the institution. The institution has submitted the reply dated 06.05.2022.

5. **AND WHEREAS**, the matter was placed before ERC in its 384th Meeting held on 09th-10th December, 2025 and committee conclude the following grounds:-

1. It will be appropriate to seek fresh Staff Profile from these 41 TEIs to take a final view in the matter. This would save the office from unnecessary litigation and avoid legal complications in the courts.
2. Once these staff profiles are considered by ERC and decision is taken in this regard, the status could be apprised to the NCTE Hqrs against their OM dated 22.09.2025 (supra).

Accordingly, A letter was issued to the institution on dated 30.01.2026 and the institution has submitted the reply 04.02.2026.

8. **AND WHEREAS**, the matter was placed before ERC in its 390th Meeting held on 09th February, 2026 and committee decided as under:-

Decision of ERC:

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- ***First SCN was issued to the institution on 28.09.2020 on certain grounds. The institution has not submitted the reply of SCN which was issued to the institution.***

- *Thereafter, the final SCN was issued to the institution on 09.04.2022. However, the institution has submitted reply of Final SCN dated 06.05.2022.*

After carefully observing the reply to final SCNs along with other related documents, the ERC concluded the following:-

- 1. It will be appropriate to seek fresh Staff Profile from these 41 TEIs to take a final view in the matter. This would save the office from unnecessary litigation and avoid legal complications in the courts.*
- 2. Once these staff profiles are considered by ERC and decision is taken in this regard, the status could be apprised to the NCTE Hqrs against their OM dated 22.09.2025 (supra).*

Accordingly, A letter was issued to the institution on dated 30.01.2026. However, the institution has submitted the reply based on 384th minutes uploaded on the NCTE website.

After carefully observing the reply of the institution with other related documents, the ERC found deficient on the following grounds.

- 1. The institution has submitted a copy of Teaching faculty list (1+06) date 29.01.2026 approved by the Registrar, B.N. Mandal University, Madhepura, Bihar, which is lesser in number than what is required under NCTE Regulation for one unit of B.Ed programme amended from time to time.*
- 2. The institution has not appointed subject wise teaching faculty as per NCTE, Regulation amended from time to time.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of the academic session next following the date of communication of withdrawal order.

8. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to **Mohan Shakuntala Teachers' Training College**, Vill:-Madhepura, Street/Road:-Ward No-04, Taluka/Mandal:-Madhepura, Town/City:-Madhepura, Dist:-Madhepura, Bihar- 852113 for running B.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

09. Further, the institution and affiliating body are hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

10. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
