ORDER

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, **Mayurakshi College of Education, Plot No. 21/895, 21/890, Vill/Po- Barabagan, Tehsil/Taluka- Suri, Town/City- Suri, Dist- Birbhum, West Bengal – 731103** was granted recognition for conducting **DEl.Ed.** programme of two year duration with an annual intake of 50 seats (One Basic Unit) vide Order No. ERC/7-148.6.3/NCTE/D.El.Ed./2013/16592 dated 02.03.2013 from the academic session 2013-2014, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, the institution submitted a letter No. 12/other/2022-23 dated 20.02.2024 to consider the request for closure of D.El.Ed. Programme.

3. **AND WHEREAS**, the matter placed before ERC in its 339th (Virtual) ERC Meeting held on 13th February, 2024 and the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the following observations were made:-

- *The Committee agreed to close down the institution as requested by the Institution vide letter dated 20.02.2024 by withdrawing the recognition granted to Mayurakshi College of Education, Plot No. 21/895, 21/890, Vill/Po- Barabagan, Tehsil/Taluka- Suri, Town/City- Suri, Dist- Birbhum, West Bengal for conducting D.El.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2023-2024. Order be issued accordingly.”*

4. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Eastern Regional Committee hereby agreed to close down the institution by withdrawing recognition granted to **Mayurakshi College of Education, Plot No. 21/895, 21/890, Vill/Po- Barabagan, Tehsil/Taluka- Suri, Town/City- Suri, Dist- Birbhum, West Bengal – 731103** for conducting **D.El.Ed. Programme** of two year duration with an annual intake of 50 students (One Basic Unit) vide order dated 02.03.2013.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993:-

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained

pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.

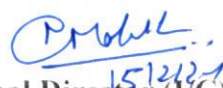
