ORDER

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, **L.K. Mishra College of Teachers Education**, Vill:- Darbhanga, Street / Road:- Dilli More, Taluka/ Mandal:- Sadar, Town/City - Darbhanga, Dist:- Darbhanga, Bihar- 846004 was granted recognition for B.Ed. programme of two year duration with an annual intake of 100 students (Two basic units) vide order No. F.No.ERC/245.6.10/D.El.Ed. & B.Ed./2017/55019 date 14.11.2017 from the academic session 2018-2019, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, a Letter Vide Letter no. NCTE-CDN016(13)/18/2018-CDN-HQ Dated 02.08.2018 received from NCTE HQ with a direction to issue show cause notice to the institution which have been recognized without NET qualified teachers.

3. **AND WHEREAS**, the aforesaid matter was considered by ERC in its 284th meeting held on 17th - 18th September, 2020 and the Committee decided to issue Show Cause Notice dated 28.09.2020 was issued to the institution. The institution has not submitted the reply of Show cause notice.

4. **AND WHEREAS**, the matter was placed again in ERC in its 303rd Meeting held on 24th March, 2022 and committee decided to issue Final Show Cause Notice dated 09.04.2022 was issued to the institution. The institution has submitted the reply dated 06.05.2022.

5. **AND WHEREAS**, the matter was placed before ERC in its 384th Meeting held on 09th-10th December, 2025 and committee conclude the following grounds:-

1. It will be appropriate to seek fresh Staff Profile from these 41 TEIs to take a final view in the matter. This would save the office from unnecessary litigation and avoid legal complications in the courts.
2. Once these staff profiles are considered by ERC and decision is taken in this regard, the status could be apprised to the NCTE Hqrs against their OM dated 22.09.2025 (supra).

Accordingly, A letter was issued to the institution on dated 30.01.2026 and the institution has submitted the reply 04.02.2026.

6. **AND WHEREAS**, the matter was placed before ERC in its 391st Meeting held on 19th February, 2026 and committee decided as under:-

Decision of ERC:

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- *First SCN was issued to the institution on 28.09.2020 on certain grounds. The institution had not submitted the reply of SCN which was issued to the institution.*
- *Thereafter, the final SCN was issued to the institution on 09.04.2022 and the institution had submitted reply of Final SCN vide letter dated 06.05.2022.*

After carefully observing the reply to final SCN along with other related documents, the ERC concluded in its 384th meeting as following:-

- 1. It will be appropriate to seek fresh Staff Profile from these 41 TEIs to take a final view in the matter. This would save the office from unnecessary litigation and avoid legal complications in the courts.*
- 2. Once these staff profiles are considered by ERC and decision is taken in this regard, the status could be apprised to the NCTE Hqrs against their OM dated 22.09.2025 (supra).*

Accordingly, a letter was issued to the institution on dated 30.01.2026. However, the institution has submitted the reply based on minutes of the 384th meeting uploaded on the NCTE website.

After carefully observing the reply of the institution with other related documents, the ERC found deficient on the following grounds.

- 1. The institution has submitted a copy of teaching faculty list (1+15) dated 17.01.2026 which is not approved by the concerned affiliating body.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of the academic session next following the date of communication of withdrawal order.

7. Accordingly, Withdrawal order vide order No. F.No.ER-391.1/NCTE/B.Ed./ERCAPP201646319(ID-10832)/BR/2026/72909-72916 Date 25.02.2026 was issued to the institution.

8. **ANDWHEREAS**, the institution has preferred appeal before Appellate Authority, NCTE against the Order dated 25.02.2026 and the Appellate Authority, NCTE decided to remand back the case to ERC.

9. **ANDWHEREAS**, the institution has submitted the reply dated 21.05.2026 as per Appeal Direction. The matter was placed again in ERC in its 397th Meeting held on 26th May, 2026 and committee decided as under:-

Decision of ERC

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, documents submitted by the institution in pursuance of Appeal order were placed before the Eastern Regional Committee and the Committee observed the following: -

- The institution was recognized for B.Ed and D.El.Ed programme from the session 2018-2019.*
- The withdrawal order vide order No. F.No.ER-391.1/NCTE/ B.Ed. /ERC APP201646319 (ID-10832)/BR/2026/72909-72916 dated 25.02.2026 was issued to the institution on certain grounds.*
- The institution preferred appeal before Appellate Authority, NCTE-HQ against the order dated 22.02.2026 and the Appellate Authority, NCTE-HQ, passed an order vide Order No. 89-119/E-404407/2026 Appeal/6th Meeting, 2026 APPLERC202615586 Date 14.05.2026, which is as under:*

"After careful consideration of the Appeal Report, the impugned order passed by the concerned Regional Committee, the record available on file, the documents placed on record, and the submissions made by the appellant institutions, the appeal committee of the council, in exercise of its appellate jurisdiction under section 18 of the NCTE Act, 1993, concluded to set aside the impugned order dated 25.02.2016 and remain the matter to the Eastern Regional Committee (ERC) for fresh consideration strictly in accordance with the direction specified herein above."

- The institution has submitted reply dated 21.05.2026 received in ERC office on 22.05.2026 as per direction of the appeal authority of NCTE.

In view of the above, the committee decided that the recognition of the institution granted vide order No. F.No.ERC/245.6.10/D.El.Ed. & B.Ed./2017/55019 dated 14.11.2017 be restored. Concerned Affiliating Body be informed accordingly.

10. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to **L.K. Mishra College of Teachers Education**, Vill:- Darbhanga, Street / Road:- Dilli More, Taluka/ Mandal:- Sadar, Town/City :- Darbhanga, Dist:- Darbhanga, Bihar- 846004 vide (B.Ed./2017/55019 date 14.11.2017) for conducting B.Ed. courses with an annual intake of 100 students (two basic units) is hereby restored.

Also order that a copy of this Order be published in the Official Gazette.
