WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to **Deshratan Rajendra Prasad Shikshak Prashikshan Mahavidyalaya, Plot no - 199, 591, 596, Street no - Thana No 2, Vill - Mainpura, Po - Sadaquat Ashram, Patna, Tehsil/Taluka - Patna Sadar, Town/City - Patna, Dist - Patna, Bihar - 800010** for conducting B.Ed. programme of two year duration with an annual intake of 100 students (two units) vide Order No. F.No.ER-242.6.16/ERCAPP4072/B.Ed./2017/53997 dated 01.08.2017 from the academic session 2018-2019, followed by revised recognition order for B.Ed. programme of two years duration with an annual intake of 50 students for (One Basic Unit) from the academic session 2018-2019 vide Order No. F.No.ER-254.12.3/ERCAPP4072/B.Ed./2018/ 56830 dated 30.04.2018 as per NCTE Regulations, 2014.

2. **AND WHEREAS**, Two Complaint letter vide letter no. NCTE-C/PG011/27/2023 complaint Section-HQ/123644 dated 15.01.2024 & NCTE-C/PG012/24/2024 complaint Section-HQ/127288 dated 17.10.2024 has been received from complaint section HQ.

3. **AND WHEREAS**, The matter was placed before 358th meeting of ERC meeting held on 06 February 2025 and the committee decided to show cause notice on certain grounds. Accordingly Show Cause Notice dated 21.02.2025 was issued to the institution and the institution has submitted the reply dated 25.03.2025 received in ERC office on 04.04.2025.

5. **AND WHEREAS**, The matter was placed again in ERC 364th meeting held on 30 April, 2025 and committee decided as under:-

The original file of the institution alongwith other related documents, NCTE Act, 1993, **Reply of Show Cause Notice**, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC:-

1. The institution not submitted bank details of each teaching faculty members.
2. The institution has submitted teaching faculty which is misprint. Hence fresh subject wise approved teaching faculty from the concerned affiliating university.
3. Further a readable copy of complaint may be forwarded to the concerned institution for comments as per request of the institution.

In view of above, the Committee has decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution before withdrawal of recognition to submit reply within 15 days from the date of issue of show cause notice.

6. **Accordingly**, Final Show Cause Notice dated 19.05.2025 and the institution has submitted the reply dated 05.06.2025.

7. **AND WHEREAS**, the matter was placed again in ERC 403rd Meeting held on 22-23rd July, 2026 and committee decided as under:-

The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the ERC after careful consideration made the following observations:-

1. *Final Show Cause Notice was issued to the institution on 19.05.2025. Accordingly, they have submitted the reply on 05.06.2025.*

After carefully observing the reply to Final SCN along with other related documents, the ERC concluded that the institution is still deficient on the following grounds: -

- 1. The institution not submitted bank details of each teaching faculty members.*
- 2. The institution has submitted teaching faculty which is misprint. Hence fresh subject wise approved teaching faculty from the concerned affiliating university.*
- 3. Further a readable copy of complaint may be forwarded to the concerned institution for comments as per request of the institution.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the academic session 2027-2028.

8. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to **Deshratan Rajendra Prasad Shikshak Prashikshan Mahavidyalaya, Plot no - 199, 591, 596, Street no - Thana No 2, Vill - Mainpura, Po - Sadaquat Ashram, Patna, Tehsil/Taluka - Patna Sadar, Town/City - Patna, Dist - Patna, Bihar - 800010** for running running B.Ed. programme is hereby withdrawn with effect from the academic session 2027-28.

9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

10. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
