**ORDER**

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, recognition was granted to Nand Kumar Hari Roy B.Ed. College, Plot No.63, Street No-Bhergawa, Vill/PO- Bhergawa, Tehsil/Taluka-Dhanarua, Town/City-Patna, Dist- Patna, Bihar-804451 for conducting D.El.Ed. programme of two year duration with an annual intake of 100 (two basic unit) vide Order No. F.No.ER-239.6.21/ERCAPP3421/D.El.Ed./2017/52772 dated 02.05.2017 from the academic session 2017-2018, as per NCTE Regulations, 2014.

2. AND WHEREAS, the institution has not submitted Performance Appraisal Report (PAR) for academic session 2022-2023. The matter was placed before ERC in its 362<sup>th</sup> Meeting held on 25<sup>th</sup> March, 2025 and the committee decided to issue Show Cause Notice.

3. Accordingly, Show Cause Notice dated 29.03.2025 was issued to the institution.

4. AND WHEREAS, the institution has submitted reply dated 11.04.2025. The matter was placed before ERC in its 366<sup>th</sup> Meeting held on 13.05.2025 and committee decided that:-

*“the recognition/permission granted to Nand Kumar Hari Roy B.Ed. College as referred above be withdrawn under Section 17 of NCTE Act, 1993 on the following grounds/reasons with effect from the academic session 2025-2026. The institution is not entitled to admit students in the above referred programmes from the academic session 2025-2026. The students admitted up to the academic session 2024-2025 shall complete their programme:*

5. Accordingly, Withdrawal Order dated 15.05.2025 was issued to the institution.

6. AND WHEREAS, the institution has submitted the representation 01.06.2025 received in ERC office on 02.06.2025 regarding request of continuation of D.El.Ed. Programme. The matter was placed before ERC in its 367<sup>th</sup> Meeting held on 04<sup>th</sup> June, 2025 and the committee decided that:-

*“The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -*

- As per decision of ERC, SCN was issued to the Institution and accordingly, the Institution has furnished the reply.
- The ERC had issued recognition order to the institution on 02.05.2017, whereas the affiliation order was issued by the Bihar Vidyalaya Pariksha Samiti, Patna on 03.02.2023. In the intervening period the college was not functioning and therefore, not able to fill the PAR for D.El.Ed programme for the session 2021-22 and 2022-23 due to non-allotment of the students by the affiliating body.

*After carefully observing the reply to SCN along with other related documents, the ERC concluded that the reply is satisfactory and decided that withdrawal order dated 15.05.2025 issued by ERC to the institution may be treated as cancelled. Accordingly order be issued to the concerned institution and State Govt / affiliating body.”*

8. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to **Nand Kumar Hari Roy B.Ed. College, Plot No.63, Street No-Bhergawa, Vill/PO- Bhergawa, Tehsil/Taluka-Dhanarua, Town/City-Patna, Dist- Patna, Bihar-804451** for conducting D.El.Ed. Programme of two year duration with an annual intake of 100 (two basic unit) *vide* Order No. F.No.ER-239.6.21/ERCAPP3421/D.El.Ed./2017/52772 dated 02.05.2017 from the academic session 2017-2018, is hereby restored until a fresh withdrawal order is issued by ERC.

Also order that a copy of this Order be published in the Official Gazette.
