ORDER

WHEREAS, Dakshin Dinajpur B.Ed. College, Vill. - Fulbari, P.S.- Gangarampur, Dist. - Dakshin Dinajpur, West Bengal-733140 (ERCAPP333) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC Order No. 19910 dated 01/08/2013, followed by revised order vide No.32112 dated 26.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 277th meeting held on 19th – 20th December, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 26/12/2019 to the institution on the following grounds:

- (i) Principal resigned but not yet replaced/appointed.
- (ii) Only 02 faculty members do not possess required qualification as per NCTE Regulations, 2014 and subsequent amendment vide Gazette Notification No.237 of NCTE published dated 09.06.2017.
- (iii) The validity of two FDRs expired.
- (iv) List of members of faculty duly approved by the affiliating university need to be submitted along with all testimonials/ academic credentials as per Appendix-4 of NCTE Regulations, 2014.

3. **AND WHEREAS**, the ERC in its 279th Meeting held on 14th -16th February, 2020. considered the matter and reply received on dated 14/01/2020 from the institution in response to Show Cause Notice dated 26/12/2019 and observed as under.

➤ 1st show cause notice u/s 17(1) issued on 20/04/2018 follow by Final show cause notice issued dated 27/11/2018 and the institution is still deficient on the following ground:-

- (i) Total built up area is not mentioned in the Building Completion Certificate (BCC) submitted by the institution.
- (ii) FDRs of Rs.5 lakh and Rs. 7 lakh is not submitted.
- (iii) Latest copy of Fire Safety Certificate duly signed by the Govt. competent Authority is not submitted.
- (iv) Website of the institution is not functional as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

4. **NOW THEREFORE**, recognition granted to the institution viz. Dakshin Dinajpur B.Ed. College, Vill. - Fulbari, P.S.- Gangarampur, Dist. - Dakshin Dinajpur, West Bengal-733140 (Code No. ERCAPP333) for B.Ed. Course is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
