ORDER

In terms of Section 14(1) of the NCT Act, 1993 **Mahatma Jyoti Rao Phoole Women's Teacher's Training College, Ram Nagar Extension, New Sanganer Road, Shyam Nagar, Sodala, Jaipur - 302019** had submitted an application to the Northern Regional Committee of National Council For Teacher Education for grant of recognition for starting **B.Ed. Course of One year duration** from the academic session **2002-2003** with an annual intake of **120 (One Hundred Twenty)** students.

2. One scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following :-

- (i) The institution has acquired the land for setting up the teacher education institution.
- (ii) The institution has constructed the building for conducting the course on the above mentioned land.
- (iii) The institution has created an Endowment Fund of Rs. 5,24,730.00 (Rupees Five Lacs Twenty Four Thousand Thirty Only) and a Reserve Fund of Rs. 4,00,000.00 (Rupees Four Lacs Only).
- (iv) The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Mahatma Jyoti Rao Phoole Women's Teacher's Training College, Ram Nagar Extension, New Sanganer Road, Shyam Nagar, Sodala, Jaipur - 302019** for **B.Ed. course of One year duration** from the academic session **2002-2003** with an annual intake of **100 (One Hundred)** students Subject to fulfillment of the following :-

- (a) That the institution will ensure that Principal / Head and at least Seven faculty members are in position for an intake of 100 (**One Hundred**) students before commencement of the course and a report of this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
- (b) The institution shall within ONE MONTH of the receipt of recognition order, convert the Endowment Fund account into a joint account in the form of FDR only (and not any other certificate) to be operated along with an official of the Regional Committee. A copy of the procedure for creation of Endowment Fund is enclosed.
- (c) That the **Reserve Fund** for an amount equal to three months salary or such other amount, whichever is higher be maintained, in the form of FDR in favour of the management / institution, for a period of not less than **SIXTY MONTHS** in a Nationalised Bank. A copy of the procedure for creation of Reserve Fund is enclosed.
- (d) The institution shall comply with the various all other norms and standards as prescribed in the NCTE Regulations.
- ✓4. Recognition is subject to the condition that the affiliating university shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/UGC/Affiliating University.
5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- ✓6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- ✓7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
