ORDER

AND, WHEREAS, the institution submitted an application received in the NRC office, on 01.02.2018 for Shifting of Premises from Near National Public Sr. Sec. School, Jagatpura, Jaipur to **Khasra no. 557, 558, 558/880, Raghunathpura (Ratlya), Diggi Road, Sanganer, Jaipur – 202029** and for change of name of the institution from “**Pragya Teacher Training College to Rama Krishna Shikshak Prashikshan Mahavidyalaya.**”

- **Shifting of the institution at new premises is permitted and the name of institution is also changed as “Rama Krishna Shikshak Prashikshan Mahavidyalaya”.**

AND, NOW, therefore, the Northern Regional Committee hereby grants permission for change of premises from **Near National Public Sr. Sec. School, Jagatpura, Jaipur, Rajasthan to Khasra no. 557, 558, 558/880, Raghunathpura (Ratlya), Diggi Road, Sanganer, Jaipur – 202029** under clause 8(9) of the NCTE Regulations, 2014 for B.Ed. (Shiksha Shastri) course with an annual intake of 2 units of 50 students each and also for change of name of the institution from **Pragya Teacher Training College to Rama Krishna Shikshak Prashikshan Mahavidyalaya.**
