RESTORATION ORDER

WHEREAS, recognition was granted to the Institution, namely **CHAMBLE B.ED. MAHAVIDYALAYA, K.S.P. MAHILA KALYAN EVAM BAL VIKAS SAMITI, PLOT NO. 2352, KHASRA NO. 2352, DHARMGADH ROAD, PACHPEDA, PORSIA, MORENA, MADHYA PRADESH** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/2-32/223404/85/2006/1186-1190 & APW01980/223404/WRC/5-6/90/2008/31740-742 dated 24-07-2006 & 23.03.2008.

2. **AND WHEREAS**, Revised Recognition order was issued to **CHAMBLE B.ED. MAHAVIDYALAYA, K.S.P. MAHILA KALYAN EVAM BAL VIKAS SAMITI, PLOT NO. 2352, KHASRA NO. 2352, DHARMGADH ROAD, PACHPEDA, PORSIA, MORENA, MADHYA PRADESH**, vide order No. WRC/APW01980/223404/2015/146194-146215 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic units of (50 students each) from the academic session 2015-2016.

3. **AND WHEREAS**, Compliance was not Submitted as per regulations 2014.

4. **AND WHEREAS**, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to Issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. **AND WHEREAS**, a Show Cause notice was issued to the institution on 08.09.2016 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order:

6. **AND WHEREAS**, the reply of show cause notice was submitted by the institution on 20.09.2016.

7. **AND WHEREAS**, the matter was placed in 259th Meeting held on September, 21-23 2016 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...Institutions which have requested for reducing intake may be permitted."

8. **AND WHEREAS**, the letter was issued to the institution on 13.10.2016 as per decision.

9. **AND WHEREAS**, the letter was issued to the institution on 26.03.2018 as per decision, and its reply received on 02.05.2018 from the institution.

10. **AND WHEREAS**, the matter was placed in 296th Meeting held on August 28-29 2018 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"The case file was seen. The WRC reduced the intake from two units to one unit as requested by the Institution. Order was issued on 13.10.2016. However, the institution has not submitted the latest approved staff profile of 1+7 according to relevant NCTE Regulations. It should also submit additional FDR for Rs.4.00 lakhs.

Hence, Show Cause Notice be issued to the institution. Reply should be submitted within one month, failing which Recognition will be withdrawn."

11. **AND WHEREAS**, the Show Cause Notice was issued to the institution on 06.09.2018. and its reply received on 05.10.2018.

12. **AND WHEREAS**, the matter was placed in 310th Meeting held on August, 19-21 2019 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"The Show Cause Notice letter was issued to the institution vide letter dated 6/9/2018 and reply received on 05/10/2018.

On perusal of the reply of the institution the committee observed that:

- The institution has submitted 1+7 staff list which is insufficient for two units of B.Ed.
- Faculty for Fine Arts & Music subject not appointed.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

13. **AND WHEREAS**, the Withdrawal order was issued to the institution on 05.09.2019.
14. **AND WHEREAS**, the institution filed an Appeal to the Council on 18.02.2020 and the Council vide its order dt. 15.09.2020 remanded back the case to the WRC, NCTE for necessary action.
15. **AND WHEREAS**, the matter was placed in 321st Meeting held on 09-11 November, 2020 of WRC and the Committee decided that "the Committee considered the matter keeping in view the directions of the Appellate Authority order dated 11.03.2021 and noted the following:-

"As per direction of the Appeal Committee vide Order dated 15.09.2020,, the original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. The institution has not appointed the faculty for Fine Arts and Performing Arts.
2. The institution is required to appoint the required faculty and submit a fresh faculty list in the prescribed format duly approved by the concerned affiliating body alongwith a faculty approval letter issued by the affiliating body."

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 14 of the NCTE Act for B.Ed course."

16. **AND WHEREAS**, the Final Show Cause Notice was issued to the institution on 01.12.2020, and its reply received on 08.02.2021.
17. **AND WHEREAS**, the matter was placed in 339th Meeting held on 28-30 July 2021 of WRC and the Committee decided that.

"This is a RPRO case and same was remanded back by the Appellate Authority.

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the Institution for B.Ed course with an annual intake of 100 students (Two units) be restored."

18. **NOW THEREFORE**, recognition dated 24-07-2006 & 23.03.2008 and revised recognition order dt. 31.05.2015 issued to the institution viz **CHAMBLE B.ED. MAHAVIDYALAYA, K.S.P. MAHILA KALYAN EVAM BAL VIKAS SAMITI, PLOT NO. 2352, KHASRA NO. 2352, DHARMGADH ROAD, PACHPEDA, PORSIA, MORENA, MADHYA PRADESH** for B.Ed. course is hereby restored permitting the total annual intake of 50 (one unit of 50 students).
