**Withdrawal Order U/S-17**

WHEREAS, recognition was granted to the institution, namely, CHAMBAL B.ED. MAHAVIDYALAYA, K.S.P. MAHILA KALYAN EVAM BAL VIKAS SAMITI, PLOT NO.2352, KHASRA NO.2352, DHARMGADH ROAD, PACHPEDA, PORSA, DISTT. MORENA, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. course with an annual intake of 100 students vide order dated 24.07.2006 & 28.03.2008.

2. AND WHEREAS, Shri Dayaram Choudhry filed W.P.No.6094/2014 (PIL) in the Hon'ble High Court at Jabalpur. The said W.P. was clubbed with the PIL filed by Shri Pawan Duby, wherein the Hon'ble Court had directed to conduct inspection of all B.Ed. institutions. The inspection of the institution was conducted u/s 13 by the NCTE Hqrs.

3. AND WHEREAS, the inspection (U/S-13) was conducted by NCTE Hqrs. On 03.09.2014.

4. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 23-01-2015.

5. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 31.05.2015.

6. AND, WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255<sup>th</sup> meeting held on 22-24 June, 2016 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

7. AND, WHEREAS, a Show cause notice was issued to the institution on 08.09.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Staff Profile for the session 2015-16 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.


8. AND WHEREAS, the reply of show cause notice was submitted by the institution on 30.09.2016.

9. AND WHEREAS, the matter was placed in 259<sup>th</sup> Meeting of WRC held on September 21-23, 2016 and the Committee decided that "...Institutions which have requested for reducing intake may be permitted.

10. AND, WHEREAS, the reduced intake order was issued to the institution on 13.10.2016.

11. AND WHEREAS, the matter was placed in 296<sup>th</sup> Meeting of WRC held on August 28-29, 2018 and the Committee decided that "...The WRC reduced the intake from two units to one unit as requested by the institution. Order was issued on 13.10.2016. However, the institution has not submitted the latest approved staff profile of 1+7 according to relevant NCTE Regulations. It should also submit additional FDR for Rs.4.00 lakhs.

**Hence, Show Cause Notice be issued to the institution. Reply should be submitted within one month, failing which Recognition will be withdrawn."**

12. AND, WHEREAS, the Show cause notice was issued to the Institution on 06.09.2018 and reply was submitted by the institution on 09.10.2018.

13. AND WHEREAS, the matter was placed in 310<sup>th</sup> Meeting of WRC held on August 19-21, 2019 and the Committee decided that "...The Show Cause Notice letter was issued to the institution vide letter dated 6/9/2018 and reply received on 05/10/2018.

**On perusal of the reply of the institution the committee observed that:**


- The institution has submitted 1+7 staff list which is insufficient for two units of B.Ed.
- Faculty for Fine Arts & Music subject not appointed.

**Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."**

14. Hence, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition of the institution **CHAMBAL B.ED. MAHAVIDYALAYA, K.S.P. MAHILA KALYAN EVAM BAL VIKAS SAMITI, PLOT NO.2352, KHASRA NO.2352, DHARMGADH ROAD, PACHPEDA, PORSIA, DISTT. MORENA, MADHYA PRADESH** is hereby withdrawn from the end of the academic session next following the date of order of withdrawal.

15. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, G-7, Sector-10, Dwarka, New Delhi-110075 **online** against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
