WITHDRAWAL ORDER

Whereas, the WRC had granted the recognition to Shree Vestabhai H Patel College Of B.Ed, At & Post- Kangavi, Tal - Dharampur, Dist. - Valsad, Gujarat for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/APW02538/323284/123rd /2009/59323-59327 dt. 18.08.2009.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Shree Vestabhai H Patel College Of B.Ed, At & Post- Kangavi, Tal - Dharampur, Dist. - Valsad, Gujarat offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 26.02.2015 from the institution, a revised recognition order no. WRC/APW02538/323284/B.Ed./2015/144723 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014 :-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255th meeting held on June 22nd - 24th, 2016 to verify the compliance of NCTE Regulations, 2014 and the Committee decided to issue show cause notice dt. 29.08.2016

And whereas, reply dt. 20.10.2016 was placed before the WRC in its 278th meeting held on July 25th - 26th, 2017 and the Committee decided as follows :-

"The case file was seen. In response to the show cause notice dt. 29.08.2016, the institute has submitted a list of one In-charge Principal/Lecturer and 6 faculty members. Out of these, In-charge Principal/Lecturer does not have the required 55% at M.Ed. The faculty requirement for one unit is one Principal and 7 Lecturers.

The institute has also not submitted FDRs for 12 lakhs in joint operation with the RD, WRC and B.C.C. from a Govt. Engineer.

If the above documents are received within one month the case will considered further, otherwise Recognition will be withdrawn."

Accordingly, WRC vide letter dt. 01.08.2017 conveyed the decision to the institution.

And whereas, reply dt. 30.08.2017 was submitted by the institution placed before the WRC in its 293rd meeting held on June 12th - 14th, 2018 and the Committee decided as follows :-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 29.08.2016 was issued followed by compliance letter dated 01.08.2017.

The institution replied vide letter dated 30.01.2018, and has submitted the staff profile of (1+6) approved by the Registrar. However, the list is not submitted in original. The Building Completion Certificate indicates that the building is under construction. The institute has not submitted additional FDRs for 4 lakhs.

Hence, Recognition is withdrawn from the session 2018-19.

FDRs, if any, be returned."

Now, therefore, the recognition of Shree Vestabhai H Patel College Of B.Ed, At & Post- Kangavi, Tal - Dharampur, Dist. - Valsad, Gujarat for conducting B.Ed. programme of two years duration with an annual intake of 100 seats (two basic units of 50 students), is hereby withdrawn from the academic session 2018-2019 in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the decision, it may prefer an appeal to national council for teacher education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against this decision under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this letter through online mode, on the NCTE Website www.ncte-india.org.


