Restoration Order

WHEREAS, the institution, namely, SHRI VESTABHAI H. PATEL COLLEGE OF BED., AT. & PO. KANGAVI, TAL. DHARMPUR, DIST. VALSAD-396050, GUJARAT was granted recognition by WRC NCTE for B.Ed. course of one year duration with an annual intake of 100 vide order No.WRC/5-6/90/2006/C-11610 dated 02.03.2007.

2. **AND WHEREAS**, the matter was considered by WRC in its 104th meeting held on July 19-20, 2008 and the Committee observed as follows:-

"WRC considered the VT report along with original file and all relevant documents and decided to serve show notice u/s 17 of NCTE Act for following deficiencies:-

1. Lease deed of land is not registered in the name of the trust.
2. Institute is running from rented premises.
3. Principal is not appointed as per norms."

Accordingly, show cause notice u/s 17 was issued dated 02.08.2008 to the institution.

3. **AND WHEREAS**, in response to the show cause notice, reply vide letter dated 27.08.2008 submitted by the institution.

4. **AND WHEREAS**, the matter was considered by WRC in its 110th meeting held on November 12-14, 2008 and the Committee observed as follows:-

"WRC considered the reply received along with original file and all relevant documents and decided to ask the institution that:-

1. Qualified Principal be appointed within 3 months from the date of issue of NCTE letter. The intimation in respect of the same must be sent to the NCTE along with the profile of the person appointed in the prescribed format of NCTE, failing which recognition of the institution will be withdrawn w.e.f. 2009-2010.
2. The institution has to move from the rented building to its own premises latest by June 2009. Before making the institution functional in its own premises, it must have the approval of the NCTE as per the procedures prescribed in the notification of NCTE dt. October 1, 2008."

Accordingly, the institution was informed vide letter dated 28.11.2008 giving an opportunity as per the provisions of Section 17 of the NCTE Act, 1993 for furnishing reply within 30 days.

5. **AND WHEREAS**, in response to the aforesaid letter, reply vide letter received dated 20.01.2009 submitted by the institution.


6. **AND WHEREAS**, the matter was considered by WRC in its 114th meeting of WRC held on February 4-5, 2009 and the Committee observed as follows:-

"WRC considered the reply received along with original file and all relevant institution to fulfill the following :-

1. *Qualified Principal be appointed within one month from the date of issue of NCTE letter. The intimation in respect of the same must be sent to the NCTE along with the profile of the person appointed in the prescribed format of NCTE (in affidavit), failing which recognition of the institution will be withdrawn w.e.f. 2009-2010.*
2. *The institution has to move from the rented building to its own premises latest by June 2009. Before making the institution functional in its own premises, it must have the approval of the NCTE as per the procedures prescribed in the notification of NCTE dt. October 1, 2008."*
7. **AND WHEREAS**, decision of 114th meeting of WRC was communicated to the institution vide WRC, NCTE letter dated 04.03.2009.
8. **AND WHEREAS**, the matter was considered by WRC in its 116th meeting held on April 3-5, 2009 and the Committee observed as follows:-
*"Qualified Principal not appointed within given time.
Hence, recognition withdrawn w.e.f. session 2009-2010."*
9. **AND WHEREAS**, withdrawal order was issued to the institution dated 18.04.2009.
10. **AND WHEREAS**, institution filed an appeal before the NCTE Appellate Authority against the aforesaid withdrawal order and the Appellate Authority vide order dated 14.07.2009 reverses the order appealed against.
11. **AND WHEREAS**, the matter was considered by WRC in its 123rd meeting held on July 28-29, 2009 and the Committee observed as follows:-
"Permitted to continue"
12. **AND WHEREAS**, continuation order was issued dated 14.08.2009 to the institution.
13. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No. WRC/APW02538/323284/B.ED.(Revised Order)/2015/144723, 732, 743,752,758,765, 779, 788 dated 31.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students) from the academic session 2015-2016.
14. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice was issued to the institution dated 29.08.2016.
15. **AND WHEREAS**, in response to the aforesaid notice, the institution has submitted reply vide letters dated 23.09.2016 & 20.10.2016.
16. **AND WHEREAS**, the matter was considered by WRC in its 278th meeting held on July 25-26, 2017 and the Committee observed as follows:-

"The case file was seen. In response to the show cause notice dt. 29.08.2016, the institute has submitted a list of one In-charge Principal/Lecturer and 6 faculty members. Out of these, In-charge Principal/Lecturer does not have the required 55% at M.Ed. The faculty requirement for one unit is one Principal and 7 Lecturers.

The institute has also not submitted FDRs for 12 lakhs in joint operation with the RD, WRC and B.C.C. from a Govt. Engineer.

If the above documents are received within one month the case will be considered further, otherwise Recognition will be withdrawn."

17. **AND WHEREAS**, letter was issued to the institution dated 01.08.2017.

18. **AND WHEREAS**, in response aforesaid letter, the institution has submitted reply vide letter dated 30.08.2017 received in WRC on 01.09.2017.

19. **AND WHEREAS**, the matter was considered by WRC in its 293rd meeting held on June 12-14, 2018 and the Committee observed as follows:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 29.08.2016 was issued followed by compliance letter dated 01.08.2017.

The institution replied vide letter dated 30.01.2018 and has submitted the staff profile of (1+6) approved by the Registrar. However, the list is not submitted in original. The Building Completion Certificate indicates that the building is under construction. The institute has not submitted additional FDRs for 4 Lakhs.

Hence, Recognition is withdrawn from the session 2018-19.

FDRs, if any, be returned."

20. **AND WHEREAS**, withdrawal order was issued to the institution dated 22.06.2018.

21. **AND WHEREAS**, institution filed an appeal before the NCTE Appellate Authority against the aforesaid withdrawal order and the Appellate Authority vide order dated 19.10.2022 decided to remand back the case to WRC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further action necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time.

22. **AND WHEREAS**, reply submitted by the institution vide letter dated 02.11.2022.

23. **AND WHEREAS**, the matter was considered by WRC in its 376th meeting held on 29th November, 2022 and the Committee has decided the following:-

"The original file of the Institution along-with other related documents, were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:



- Recognition was granted for B.Ed. course vide order dated 02.03.2007.
- While conducting inspection on 08.06.2008, it has come to notice that institution runs in a rented premises. Accordingly, show cause notice dated 02.08.2008 was issued followed by letters dated 28.11.2008 and 04.03.2009.
- The institution has not shifted to its own premises.
- Recognition for B.Ed. course was withdrawn w.e.f. session 2009-2010 vide order dated 18.04.2009 and on reversal of withdrawal order by Appellate Authority, institution was permitted to continue vide order dated 14.08.2009.
- Revised order was issued dated 31.05.2015 in pursuance of NCTE Regulations, 2014.
- Show cause notice dated 29.08.2016 was issued in the matter of compliance of conditions of revised recognition order followed by letter dated 01.08.2017.
- Recognition for B.Ed. course was withdrawn for the second time from the academic session 2018-2019 vide order dated 22.06.2018.
- Matter remanded back vide order dated 19.10.2022 passed by NCTE Appellate Authority.
- Documents submitted by the institution in compliance of appellate order was considered by WRC and found satisfactory.

In view of the above, the Committee decided that recognition for B.Ed. course be restored. The concerned State authorities be intimated accordingly. A copy of restoration order be also uploaded on the WRC web portal on NCTE website."

24. **NOW THEREFORE**, recognition of institution viz. SHRI VESTABHAI H. PATEL COLLEGE OF BED, AT. & PO. KANGAVI, TAL. DHARMPUR, DIST. VALSAD 396050, GUJARAT for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) is hereby restored.

25. The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dated 31.05.2015.


