WITHDRAWAL ORDER

Whereas, the WRC had granted the recognition to Shree Brahmanand Institute of Teacher Education, (Run by Brahmchri Shree Bhagavatinandji Education Trust), Shree Bramanand Education Campus, At. Chaparda, Post - Juni Chawand, Tal. - Visavadar, Dist. - Junagadh, Gujarat - 362120 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/103<sup>rd</sup>/2008/34457-34462 dt. 13.05.2008.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Shree Brahmanand Institute of Teacher Education, (Run by Brahmchri Shree Bhagavatinandji Education Trust), Shree Bramanand Education Campus, At. Chaparda, Post - Juni Chawand, Tal. - Visavadar, Dist. - Junagadh, Gujarat - 362120 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 09.01.2015 from the institution, a revised recognition order no. WRC/APW05460/323519/2015/144570 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014 :-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, on non-receipt of above documents from the institution, the matter was placed before the WRC in its 255<sup>th</sup> meeting held on June 22<sup>nd</sup> - 24<sup>th</sup>, 2016 to verify the compliance of NCTE Regulations, 2014 and the Committee decided to issue show cause notice dt. 26.08.2016

And whereas, reply dt. 07.02.2017 was placed before the WRC in its 294<sup>th</sup> meeting held on July 4<sup>th</sup> - 5<sup>th</sup>, 2018 and the Committee decided as follows :-

"The case file was seen. Show Cause Notice was issued to the institution on 26.08.2016 and the institution replied on 07.02.2017. The institution has not submitted the documents mentioned in the Show Cause Notice - staff profile, Building Completion Certificate and additional FDR for Rs.4.00 lakhs.

Hence, Recognition is withdrawn."

Now, therefore, the recognition of Shree Brahmanand Institute of Teacher Education, (Run by Brahmchri Shree Bhagavatinandji Education Trust), Shree Bramanand Education Campus, At. Chaparda, Post - Juni Chawand, Tal. - Visavadar, Dist. - Junagadh, Gujarat - 362120 for conducting B.Ed. programme of two years duration with an annual intake of 100 seats (two basic units of 50 students), is hereby withdrawn from the end of the academic session next following the date of this withdrawal order in terms of Section 17(1) of the NCTE Act, 1993.
