RESTORTION ORDER

Whereas, recognition was granted to the institution, namely, **Shree Brahmahand Institute of Teacher Education, Shree Brahmahand Education Campus, At- Navichavand, Tehsil - Visavadar, District - Junagadh, Gujarat - 362120** under Section 14 of NCTE Act, 1993 for conducting B.Ed. course with an annual intake of 100 students vide order no.WRC/5-6/103th/2008/34457-34462 dated 13.05.2008.

2. And whereas, after the promulgation of NCTE (Recognition, Norms & Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Shree Brahmahand Institute of Teacher Education, Shree Brahmahand Education Campus, At. Navichavand, Tehsil - Visavadar, District - Junagadh, Gujarat - 362120 offering B.Ed. course was informed vis email/public notice to submit a dully notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

3. And whereas, after the receipt of affidavit dt. 09.01.2015 from the institution, a revised recognition order no. WRC/APW5460/323519/2015/144570 dt. 31.05.2015 was issued to the institution for conducting B.Ed programme of two years duration with an annual intake of 100 students (two basic unit of 50 students) from session 2015-16.

4. And whereas, the matter was placed before the WRC in its 255th meeting held on June 22-24, 2016 and the Committee decided to issue show cause notice dt. 26.08.2016 to the institution.

5. And whereas, reply has submitted by the institution on dt. 07.02.2017 and matter was placed before the WRC in its 294th meeting held on July 04th - 05th, 2018 and the Committee decided as follows:-

" The case file was seen. Show Cause Notice was issued to the institution on 24.08.2016 and the institution replied on 07.02.2017. The institution has not submitted the documents mentioned in the Show Cause Notice - Staff profile, Building Completion Certificate and additional FDR for Rs. 4.00 lakhs.

Hence, Recognition is withdrawn.

6. And whereas, a withdrawal order no. WRC/APW05460/323519/Guj. /294th/2018/ 199203-199208 dt. 10.07.2018 was issued to the institution.

7. And whereas, the institution has filed an appeal at NCTE Hqrs. NCTE Delhi and the Appellant Authority vide order dt. 12.09.2018 has decided as follows:-

"After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the committee concluded that the matter deserved to be remanded to the W.R.C. for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously.

The Council hereby remands back the case of Shree Brahmahand Institute of Teacher Education, Chaparda, Juni Chawand Road, Visavadar, Gujarat to the WRC, NCTE, for necessary action as indicated above."

8. And whereas, reply dt. 25.09.2018 of institution was placed before the WRC in its 299th meeting held on October 30th - November 1st, 2018, and committee decided as follows:-

"This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC for revisiting the matter for considering the list of faculty submitted by the appellant institution. On perusal of the reply dated 20.09.2018 submitted by the institution, the committee observed that:-

The institution has submitted the approved staff list of 1+15 faculty members, As per NCTE Regulations, 2014, faculty is required for Fine Arts/Performing Arts & Physical Education.

Hence, the Committee decided that Show Cause Notice be issued to the institution. Reply should be submitted within one month, failing which recognition will be withdrawn u/s 17 (1) of the NCTE Act, 1993."

9. And whereas, Show Cause Notice no.WRC/APW05460/323519/299th/B.Ed/Guj./2018/200654-200656 dt. 15.11.2018 was issued to the institution.

10. And whereas, institution filed an S.C.A. No. 13346/2018 before the Hon'ble High Court of Gujarat at Ahmedabad. The Hon'ble High Court vide order dt. 30.10.2018 decided as follows:-

"The Hon'ble Court has passed the following order/Judgment Goram: Honourable Mr. justice S.H. Vora date : 30/10/2018 oral Order In view of order dated 12.09.2018 passes by member secretary, N.C.T.E., present petition stands disposed of.

Orders accordingly for the compliance of the directions given by the Hon'ble Court in the above order."

11. And whereas, reply dt. 14.12.2018 of institution was placed before the WRC in its 307th meeting held on May 30th - 31st, 2019 and Committee decided as follows:-

"In view of the direction of the Hon'ble High Court Gujarat at Ahmedabad SCA No. 13346 of 2018 converted from SCA/26173/2018 order dated 29/08/2018.

The WRC considered the reply of the institution 14/12/2018 and decided to restore the recognition of two years B.Ed. programme of two basic unit. "

12. Now Therefore, the recognition granted to the institution for conducting B.Ed course has been restored as per decision of the WRC in its 307th meeting and the institution is permitted to continue the existing B.Ed. course of two years duration with an annual intake of 100 seats (two basic unit of 100 students).

13. It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.

Revised order no. WRC/APW05460/323519/2015/144570 dt. 31.05.2015 be treated as cancelled from the date of issue of the order.
