WHEREAS, recognition was granted to the institution, namely, ARICENT COLLEGE OF EDUCATION, RUN BY- GAURI SHANKAR MULLA DEVI SHIKSHA AVAM VIKAS SANSTHA, H.NO. 22/47, INDIRA GANDHI WARD, KURWAI ROAD, BINA, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. (CO-ED).course vide order dated 29.07.2008 for an annual intake of 100 students.

AND WHEREAS, Shri Dayaram Choudhry filed W.P. No.6094/2014. (PIL) in the Hon'ble High Court at Jabalpur. The said W.P. was clubbed with the PIL filed by Shri Pawan Dubey, wherein the Hon'ble court had directed to conduct inspection of all B.Ed. institutions. The inspection of the institution was conducted u/s 13 by the NCTE Hqrs.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 18.12.2014.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 16.01.2015 and the reply was received on 19.01.2015.

AND WHEREAS, Revised Recognition order was issued to the institution on 31.05.2015.

AND WHEREAS, the Deficiency Letter was issued by the NCTE HQRs. to the institution on 27.07.2015 and the institution submitted reply received on 14.09.2015 & 17.09.2015 and forwarded to NCTE Hqrs.

AND WHEREAS, the VTR alongwith file of the institution were received from NCTE Hqrs. in WRO on 26.07.2016.

AND WHEREAS, the matter was placed in 258th meeting of WRC held on August 22-24, 2016 and the Committee decided that "... Deficiency letter dt. 27/07/2015 was issued by NCTE Hqrs. The institution submitted the replies dt. 14/09/2015 and 17/09/2015 (papers were received in WRC on 26/07/2016). After examination of the replies of the institution to the deficiency letter, the following points emerge:-

i) **Engagement of faculty for all pedagogical courses & engagement of teacher with background in Science discipline :**

The institution has explained that for the session 2014-15, Science teacher was arranged by way of guest lecturer. It has also been written that recruitment process is going on, and the list of the persons will be forwarded.

This institution was recognized for B.Ed. in July 2008. It is strange that even though 8 years have passed regular staff approved by the University has not been appointed. Secondly, the reply in which the list of selected staff was promised to be sent is dated 14/17-September 2015. It is almost a year since this reply was received, but no list has been received till date. This situation is most unsatisfactory.

ii) **Improved service conditions :**

The institution has written that it will try to improve service conditions.

But no proof has been submitted as to what action is being taken. All teacher education institutions are bound to implement the Section 10(2) and (3) of the NCTE Regulations, 2014- payment of regular salary as per norms, and payment of EPF.

iii) **Improvement of Academic environment; preparation and implementation of annual institution development plan :**

The institution has claimed that it has organized Workshops and Seminars but no proof has been submitted. No reply has been submitted on institutional development plan. Thus, explanation is not satisfactory.

vi) NAAC Accreditation :

The institution has promised that it will apply for NAAC accreditation.
Even though one year has passed, no communication has been received from the institution.

v) Updation of Website:

The institution has claimed that the website has been updated, but no proof has been submitted.
Thus, explanation is not satisfactory.

Show Cause Notice be issued on all the grounds mentioned above."

AND WHEREAS, Show cause notice was issued by the WRC to the institution on 29.08.2016 and the reply of Show cause notice was not submitted by the institution.

AND WHEREAS, the matter was placed in 261th meeting of WRC held on October 26-28, 2016 and the Committee decided that "... Show Cause Notice was issued on 29/08/2016 and reply has not been received till date.

Hence, Recognition is withdrawn under Section 17 of the NCTE Act, from the end of the academic session next following the date of withdrawal."

AND WHEREAS, the Withdrawn order was issued by the WRC on 02.11.2016.

AND WHEREAS, appeal filed by the institution u/s-18 of the NCTE Act, 1993 on 30.12.2016.

AND WHEREAS, Appeal order dated 29-05-2017, Decision Direction of the Appellate Authority "...The committee, concluded that the appeal deserves to be remanded to the WRC with a direction to consider the reply of the appellant to the Show Cause Notice to be resubmitted by them, and take further action as per the NCTE Regulations 2014. The appellant is directed to send their reply to the show cause notice with all relevant documents again to the WRC within 15 days of receipt of the order on the appeal. In the meantime, time withdrawal order shall be kept in abeyance."

NOW THEREFORE, the Council hereby remands back the case of Aricent College of Education, Bina, Sagar, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

AND WHEREAS, the matter was placed in 277th meeting of WRC held on June 29-30, 2017 and the Committee decided that "... This is a case of Appeal. Recognition was withdrawn on the ground that the institution had not replied to the deficiency letter. The institution submitted a copy of the reply which seems to have been sent to WRC in response to the Show Cause Notice but which was never received in the WRO.

The institution is required to send a copy of the reply, which was submitted to the Appellate Authority, to the WRO with all the details. As per Appeal order, the order of withdrawal is kept in abeyance.

Show Cause Notice be issued on the above grounds and reply should be received within 1 month."

AND WHEREAS, Show cause notice was issued by the WRC to the institution on 04.07.2017 and the reply of Show cause notice was received on 17.07.2017.

AND WHEREAS, the matter was placed in 279th meeting of WRC held on August 10-11, 2017 and the Committee decided that "... In reply to Show Cause Notice, the institute has submitted a staff list approved by the university.

Hence, recognition is restored."
