Withdrawal Order U/S-17

Whereas, the recognition was granted to the institution, namely, VEENA VADINI EDUCATIONAL AND, PRASHIKSHAN SANSTHAN, E-4/84, ARERA COLONY, BHOPAL, MADHYA PRADESH (APW01773/223323) for B.Ed. Course vide order No. WRC/ 2-32/223323/74/2005/4912 dated 27.06.2005.

AND, WHEREAS, Shri Pawan Dubey filed W.P. No 2370/2012 (PIL) in the Hon'ble High Court at Jabalpur. The Hon'ble Court directed NCTE to conduct inspection of all B.Ed. institutions in the State of Madhya Pradesh.

AND, WHEREAS, letter was issued to the institution on 17.01.2015 (Affidavit regarding acceptance and Compliance of NCTE Regulations, 2014). The institution submitted the Affidavit.

AND, WHEREAS, revised order was issued to the institution on 31.05.2015.

AND, WHEREAS, inspection of the institution U/S 13 was conducted on 17.11.2014 by NCTE Hqrs.

AND, WHEREAS, the institution was sent letter dated 28.04.2015 by NCTE Hqrs. pointing out the deficiencies. The institution submitted reply, received in NCTE Hqrs on 30.05.2015.

AND, WHEREAS, VT report alongwith file of the institution were received in WRC office on 12.11.2015.

AND, WHEREAS, the matter was placed in 237th Meeting held on December 21-22, 2015 of WRC and the Committee decided that "... The reply of the institution was examined in the context of the inspection report of the NCTE Hqrs. conducted under section 13 of the NCTE Act, 1993. The following lacunae are seen from the reply of the institution:-

- (i) The VT has noted that no multipurpose hall is available in the college building, whereas the college has enclosed a map in which a hall in the basement as multipurpose hall is demarcated. Hence, it is necessary that the institution should provide reliable proof of the availability of the multipurpose hall. The Head of the sponsoring Society/Principal of the college should provide an Affidavit on this issue;
- (ii) The institution has claimed that it has applied for appointment of Principal under code 28. No proof has been provided so far. The institution should submit Staff profile duly approved by the affiliating body; and
- (iii) The institution has claimed that it will apply for NAAC Accreditation Certificate. Proof of this claim should also be provided.

Hence, Show Cause Notice be issued on the above grounds."

AND, WHEREAS, SCN was issued to the institution on 05.01.2016. The reply was received on 06.02.2016

AND, WHEREAS, the matter was placed in 246th Meeting held on March 16-18, 2016 of WRC and the Committee decided that "... Consequent to the consideration of the reply of the institution to the points raised after inspection under Section 13, the WRC had issued a Show Cause Notice on 05/01/2016. The institution vide reply dt. 06/02/2016 has given the following responses :

- i) A certificate from the Govt. Engineer regarding construction of the multipurpose hall is not submitted.
- ii) The institution has not submitted the staff profile approved by the Registrar of the University. Further, the institution should appoint staff as per the NCTE Regulations, 2014 i.e. 16 faculty members for two units of the B.Ed. course.

Hence, Clarification be obtained on the above grounds."

AND, WHEREAS, letter seeking Clarification was issued to the institution on 22.03.2016 and reply was received on 20.04.2016.

AND, WHEREAS, the matter was placed in **252th Meeting held on May 09-10, 2016** of WRC and the Committee decided that "... Clarificatory letter was issued on 22/03/2016. The institution has submitted a certificate from a Govt. approved Engineer and Valuer who has certified that the multipurpose hall is 207 sq. mtrs. Regarding staff, the institution has informed that the faculty selection is under process.

Compliance in these matters be submitted by 30th of May 2016."

AND, WHEREAS, letter seeking Clarification was issued to the institution on 17.05.2016 and reply was received on 31.05.2016.

AND, WHEREAS, a Complaint from the Higher Education Dept. was received on 20.05.2016 informing that the institution is not functioning from the location at which it was granted recognition.

AND, WHEREAS, the matter was placed in **254th Meeting held on June 07- 09, 2016** of WRC and the Committee decided that "... Clarificatory letter was issued on 17/05/2016 and reply was received on 31/05/2016. The institution has submitted a letter from the University regarding selection of 6 staff members. However, the institution has not given any definitive document regarding the appointment of Principal and the appointment of Physical Education, Art & Craft, and Music lecturers. Secondly, the institution has not submitted individual Affidavits of candidates selected in May, 2016 and also there are no documents regarding Physical Education, Art & Craft, and Music lecturers. There is no Affidavit from the Principal.

The WRC had issued Show Cause Notice to the institution on 05/01/2016, letter seeking clarifications on 22/03/2016 and 17/05/2016 regarding the appointment of staff. In spite of so many opportunities, the institution has not been able to appoint faculty members as required by the Regulations.

Hence, Recognition of the institution for B.Ed. course is withdrawn under Section 17 of the NCTE Act, 1993, from the academic session 2016-2017."

Now, therefore, in exercise of the powers vested in WRC U/S 17 of the NCTE Act, 1993, the recognition of the institution for B.Ed. course is hereby withdrawn from the academic session 2016-2017.


