WHEREAS, recognition was granted to the institution, namely, VEENA VADINI EDUCATIONAL AND PRASHIKSHAN SANSTHAN E-4/84, ARERA COLONY, BHOPAL MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. (CO-ED).course vide order dated 27.06.2005 & 26.09.2009 (Restoration order) for an annual intake of 100 students.

AND WHEREAS, one Shri Pawan Dubey had filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court had directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since, the institutions are existing institutions, the inspection was to be conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 17.11.2014.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 18.01.2015.

AND WHEREAS, Revised Recognition order was issued to the institution on 31.05.2015.

AND WHEREAS, the Deficiency Letter was issued by the NCTE HQRs. to the institution on 28.04.2015 and the reply of Deficiency Letter was received in NCTE HQRs. on 30.05.2015.

AND WHEREAS, the VTR alongwith file of the institution were received from NCTE Hqrs. in WRO on 12.11.2015.

AND WHEREAS, the matter was placed in 237th meeting of WRC held on December 21-22, 2015 and the Committee decided that "... The reply of the institution was examined in the context of the inspection report of the NCTE hqrs conducted under section 13 of the NCTE Act, 1993. The following lacunae are seen from the reply of the institution:-

- The VT has noted that no multipurpose hall is available in the college building, whereas the college has enclosed a map in which a hall in the basement as multipurpose hall is demarcated. Hence, it is necessary that the institution should provide reliable proof of the availability of the multipurpose hall. The Head of the sponsoring Society/Principal of the college should provide an Affidavit on this issue;
- The institution has claimed that it has applied for appointment of Principal under code 28. No proof has been provided so far. The institution should submit Staff profile duly approved by the affiliating body; and
- The institution has claimed that it will apply for NAAC Accreditation Certificate. Proof of this claim should also be provided.

Hence, Show Cause Notice be issued on the above grounds."

AND WHEREAS, Show cause notice was issued by the WRC to the institution on 05.01.2016 and the reply of Show cause notice was received on 06.02.2016.

AND WHEREAS, the matter was placed in 246th meeting of WRC held on March 16-18, 2016 and the Committee decided that "... Consequent to the consideration of the reply of the institution, to the points raised after inspection under Section 13, the WRC had issued a Show Cause Notice on 05/01/2016. The institution vide reply dt. 06/02/2016 has given the following responses :

- A certificate from the Govt. Engineer regarding construction of the multipurpose hall is not submitted.
- The institution has not submitted the staff profile approved by the Registrar of the University. Further, the institution should appoint staff as per the NCTE Regulations, 2014 i.e. 16 faculty members for two units of the B.Ed. course.

Hence, Clarification be obtained on the above grounds."

AND, WHEREAS, Clarification was issued to the institution on 22.03.2016 and reply was received 20.04.2016.

AND WHEREAS, the matter was placed in 252nd meeting of WRC held on May 09-10, 2016 and the Committee decided that "... Clarificatory letter was issued on 22/03/2016. The institution has submitted a certificate from a Govt. approved Engineer and Valuer who has certified that the multipurpose hall is 207 sq. mtrs. Regarding staff, the institution has informed that the faculty selection is under process. It

Compliance in these matters be submitted by 30th of May 2016."

AND, WHEREAS, letter seeking Clarification was issued to the institution on 17.05.2016 and reply was received 31.05.2016.

AND, WHEREAS, Complaint letter received from Higher Education Dept. Satpuda Bhawan, Bhopal on 20.05.2016, and letter sent to OSD Higher Education Dept. Satpuda Bhawan, Bhopal on 21.05.2016

AND WHEREAS, the matter was placed in 254th meeting of WRC held on June 07-09, 2016 and the Committee decided that "... Clarificatory letter was issued on 17/05/2016 and reply was received on 31/05/2016. The institution has submitted a letter from the University regarding selection of 6 staff members. However, the institution has not given any definitive document regarding the appointment of Principal and the appointment of Physical Education, Art & Craft, and Music lecturers. Secondly, the institution has not submitted individual Affidavits of candidates selected in May, 2016 and also there are no documents regarding Physical Education, Art & Craft, and Music lecturers. There is no Affidavit from the Principal.

The WRC had issued Show Cause Notice to the institution on 05/01/2016, letter seeking clarifications on 22/03/2016 and 17/05/2016 regarding the appointment of staff. In spite of so many opportunities, the institution has not been able to appoint faculty members as required by the Regulations.

Hence, Recognition of the institution for B.Ed. course is withdrawn under Section 17 of the NCTE Act, 1993, from the academic session 2016-2017."

AND WHEREAS, the Withdrawn order was issued by the WRC on 16.06.2016.

AND WHEREAS, appeal filed by the institution u/s-18 of the NCTE Act, 1993 on 19.07.2016.

AND WHEREAS, Appeal order dated 26-09-2016, Decision Direction of the Appellate Authority "...The committee, being satisfied with the efforts made by the appellant in getting the faculty selected/approved, conclude that the matter deserved to be remanded to the WRC with a direction to consider the list selected faculty forwarded to them and take a fresh decision in the matter as per the NCTE Regulations. In the meanwhile, the withdrawal order will be kept in abeyance."

AND WHEREAS, the matter was placed in 272nd meeting of WRC held on April 06-08, 2017 and the Committee decided that "...The case file was seen. The appellate authority vide order dt. 26/09/2016 has asked the WRC to re-examine the staff profile.

The WRC re-examined the staff profile and found that the subjects under PG qualification are not mentioned.

Secondly, individual affidavits on NCTE Proforma are not submitted.

Thirdly, consolidated list of staff with all details through an Affidavit is not submitted.

The experience certificate of the Principal with details about the length of service and the names of the institutions is not submitted.

The case will be considered further on receipt of the reply to the above.

Hence, Clarification be obtained on the above grounds."

The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 02.05.2017, can the case be considered for the session 2017-2018."

AND, WHEREAS, letter seeking Clarification was issued to the institution on 18.04.2017 and reply was received 02.05.2017.


AND WHEREAS, the matter was placed in 277th meeting of WRC held on June 29-30, 2017 and the Committee decided that "... The institution has fulfilled all the required clarifications. However, it is seen that in the staff profile, the candidate at serial no. 6 does not possess the required 55% marks at the PG level and should not be appointed.

The institution should submit FDRs for Rs. 12 lakhs in joint name with the RD, WRC as required under the NCTE Regulations, 2014. On receipt of the required FDRs, the recognition be restored."

AND WHEREAS, the Clarification letter was issued to the institution on 04.07.2017 and reply was received from the institution on 06.07.2017. with original joint FDRs of Rs. 5+7 = 12 Lakhs.

NOW THEREFORE, the recognition of VEENA VADINI EDUCATIONAL AND, PRASHIKSHAN SANSTHAN E-4/84, ARERA COLONY, BHOPAL MADHYA PRADESH for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each) is hereby restored.


