WITHDRAWAL ORDER

Whereas, WRC, NCTE granted Recognition/Permission to run P.T.C course for four units vide recognition order Nos. (1) No.WRC/5-6/40/2002/05961 dt. 30.09.2002 (one unit), (2) No.WRC/2-32/62/2004/4949 dt. 03.08.2004 (one unit) and (3) No.WRC/2-32/322016/72/2005/4124 dt 13.05.2005 (two unit) of institution ANANDBA MAHILA ADHYAPAN MAHAVIDYALAYA, KARAI GAAM ROAD, NAANA CHILODA OCTROI NAKA, AT & PO - VALAD, , GANDHINAGAR, Gujarat

And, whereas, Institution vide its letter dt. 27.03.2010 requested to withdraw recognition of two units of P.T.C. course out of its four units. The matter was placed in 133rd meeting of WRC . WRC considered request of the institution and resolved that **withdrawal of two units of the P.T.C from four units permitted as requested by the institution.**

Accordingly the recognition of two units from the granted four unit has been withdrawn Vide order No.WRC/APW00413/322016/133/2010/ 67615 dtd.05/04/2010.

And, whereas, the office of WRC has again received request letter dt. 07.01.2012 from the Managing Trustee of the Trust with a request to close down the remaining two units of its P.T.C. course.

And whereas, the matter was placed before WRC in its 159th meeting held on 7-9 Feb, 2012 and after considering the records available in the file and relevant provisions, the Committee decided to withdraw recognition of PTC course as per request made by the institution

Now therefore, the recognition granted to ANANDBA MAHILA ADHYAPAN MAHAVIDYALAYA, KARAI GAAM ROAD, NAANA CHILODA OCTROI NAKA, AT & PO - VALAD, , GANDHINAGAR, Gujarat for PTC Course for remaining two units is hereby withdrawn.
