**RESTORATION ORDER**

**WHEREAS**, the institution, namely, "AEC Training College of Centre, Pachmarhi, Distt. Hoshangabad, Madhya Pradesh was granted recognition for B.Ed. and M.Ed. course from the academic session 2000-2001 with an annual intake of 40 for B.Ed. and 10 for M.Ed. Students vide Order WRC/5-6/2k/122-127 dated 10.01.2001.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014 the institution had consented to come under new Regulation by affidavit, and the Revised Provisional Recognition Order (RPRO) was issued to the institution vide Order No.WRC/OAPW0149/213025/223064/259<sup>th</sup>/2016 dated 04.10.2016 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic units of 50 students) from the academic session 2015-2016.

3. **AND WHEREAS**, the matter was considered by the Western Regional Committee of NCTE in its meeting No 416<sup>th</sup> held on 20<sup>th</sup> to 21<sup>st</sup> March 2025 and as per the decision taken by the Regional Committee to issue Show Cause Notice. Accordingly, as per the decision of WRC Show Cause Notice was issued to the institution on 15.04.2025.

4. **AND WHEREAS**, the matter was considered in its WRC 424<sup>th</sup> meeting held on 20, May 2025 Committee decided to issue withdraw the recognition. Accordingly, Withdrawal Order No. NCTE/2025/WRC/PAR/ORDER/OAPW0149/213025/6120-25 dated 31.05.2025 for B.Ed. was issued to the institution.

5. **AND WHEREAS**, an appeal was file under section 18 of NCTE Act order No. 89-463/E-387993/2025 Appeal/14<sup>th</sup> Meeting, 2025 (APPLWRC202515416/E-88895/134214) dated 15.12.2025.

6. **AND WHEREAS**, the matter was considered by WRC in its 454<sup>th</sup> Meeting held on 11<sup>th</sup> March 2026, wherein the Committee decided as under:-


*"The file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Western Regional Committee and the Committee observed the following: -*

- (i) *The institution was granted recognition for B.Ed. course of one-year duration with an annual intake of 40 students vide order dated 10.01.2001 followed by revised recognition order dated 04.10.2016 for B.Ed. course of two-year duration with annual intake of 50 students (1 units).*

- (ii) The recognition of the institution was withdrawn by WRC vide Order No. NCTE/ 2025/ WRC/PAR/ORDER/OAPW0149/213025/6120-25 dated 31.05.2025.
- (iii) The institution filed an appeal under Section 18 of the NCTE Act 1993 before the Council and the Appellate Authority vide its Order dated 15.12.2025 concluded to set aside the impugned order dated 31.05.2025 and remanded back the case to Western Regional Committee for fresh consideration in accordance with the directions to re-examine the submission of PAR by the institution and consider the documentary evidence furnished with the appeal in accordance with the provisions of the NCTE Regulations 2014 and guidelines issued from time to time.

**“In view of the above, the Committee considered the facts and documents related to the case and decided to restore the recognition granted to the institution for B.Ed of two-year duration with an annual intake of 50 students (One Unit). However, the said Institution is also directed to submit the documents provided along with the appeal for scrutiny and verification by the Western Regional Committee, within fifteen (15) days of receipt of the restoration order. The order be issued accordingly.”**

7. **NOW THEREFORE**, in pursuance of the appeal Order dated 15.12.2025, the Western Regional Committee hereby restores the recognition of **“AEC Training College of Centre, Pachmarhi, Distt. Hoshangabad, Madhya Pradesh”** for B.Ed. Course of two years duration with an annual intake of 50 students (one basic unit).
