RESTORATION ORDER

WHEREAS, the recognition was granted to the institution namely **K.J. Somaiya Comprehensive College of Education, Training and Research, Vidyavihar, Rajawadi, Dist-Mumbai, Maharashtra-400077**. For **M.Ed. (CO-ED)** programme of **1 (one) years** duration with an annual intake of **40 students** Vide Order No. WRC/5-6/92(Ext.)/2006/ dated 24.12.2006.

AND WHEREAS, the Revised Recognition order was issued to the institution for M.Ed. programme for the academic session 2015-2016 with an annual intake of **50 students (one basic unit of 50 students each)** Vide order No. F.No.WRC/APW03364/125041/2015/152495 dated: 09.09.2015.

3. AND WHEREAS, the matter regarding Compliance by the institutions of the condition of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided that Show Cause Notice be issued to all such institution which have not submitted Compliance.

Accordingly, as per the decision of WRC show cause notice was issued vide No. Ref. No./WRC/APW03364/125041/MH/2016/175505-506 dated: 04 November, 2016.

4. AND WHEREAS, the institution has submitted reply vide letter No. Ref. No. : K/2016/373 dated: 21 November, 2016 Compliance of RPRO.

5. AND WHEREAS, the matter was considered by WRC in its 416th Meeting held on 20th to 21st March 2025 wherein the Committee decided as under:-

"The matter was considered by WRC in its meeting and as per decision taken by the Western Regional Committee, Show cause Notice to provide reasonable opportunity to submit representation before withdrawal of the above recognition/permission u/s 17 of NCTE Act, 1993 on the ground of non-submission of the PAR for the academic session 2022-23 was issued by the WRC to the institution through online mode on 05.04.2025, a copy of the same was also sent through speed post."

Accordingly, as per the decision of WRC show cause notice was issued vide No. Ref. No. Ref. No. Ref. No. NCTE/2025/WRC/PAR/APW03364/125041 dated. 05.04.2025.

6. AND WHEREAS, the matter was considered by WRC in 423rd meeting of WRC held on 15.05.2025 and committee decided as under:-



"In view of the above, the Committee considered the facts and documents related to the case and decided to restore the recognition granted to the institution for M.Ed of two-year duration. However, the said Institution is also directed to submit the documents provided along with the appeal for scrutiny and verification by the Western Regional Committee, within fifteen (15) days of receipt of the restoration order. The order be issued accordingly."

11. NOW THEREFORE, the Western Regional Committee hereby restores recognition of K.J. Somaiya Comprehensive College of Education, Training and Research, Vidyavihar, Rajawadi, Dist- Mumbai, Maharashtra- 400077 for M.Ed. programme 1 years duration with an annual intake of 50 students (One basic unit of 50 students each).
