ORDER

WHEREAS, WRC, NCTE had granted recognition/permission to DELHI PUBLIC ACADEMY, PLOT NO. B-5, STREET NO. B-5, TEHSILGWALIOR, CITY- GWALIOR, POST OFFICE- DEEN DAYAL NAGAR, - 474006, DISTRICT- GWALIOR, MADHYA PRADESH vide order dated 18.125.2006 to start the B.ED. (CO-ED) course with an annual intake of 100 students.

AND WHEREAS, the letter for- submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 14.01.2015. The institution submitted affidavit vide letter dated 16.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units of (50 students each) to the institution on 31.05.2015.

AND WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...issue Show Cause Notices to the institution of the condition maintained in revised order."


AND, WHEREAS, the Compliance Show Cause Notice was issued to the institution on 01.09.2016 and the reply of Show Cause Notice was received on 03.10.2016.

AND WHEREAS, the matter was placed in 296<sup>th</sup> Meeting of WRC held on August 28-29, 2018 and the Committee decided that "... Show Cause Notice was issued to the institution on 01.09.2016 and reply received on 03.10.2016. Since, the institution has submitted a staff profile of 1+7, the intake is reduced from two units to one unit."

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

NOW, THEREFORE, the intake of the institution for conduct of B.Ed. course is hereby permitted to reduce the intake of 100 students (2 basic units) to 50 students (one unit.)


