RESTORATION ORDER

Date: 09/08/18

WHEREAS, recognition was granted to the institution, namely, ANNIE BESANT COLLEGE, RAJENDRA NAGAR, 47-48 PRECANCO COLONY, ANNAPURNA ROAD, INDORE MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. (CO-ED).course vide order dated 19.04.2009 for an annual intake of 100 students.

AND WHEREAS, one Shri Pawan Dubey had filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court had directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since, the institutions are existing institutions, the inspection was to be conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 09.01.2015.

AND, WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 31.05.2015.

AND, WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...Follow up of Revised Orders for B.Ed. courses: The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item"

AND WHEREAS, the Show Cause Notice of compliance issued on 03.01.2017 and reply of compliance received on 30.01.2017.

AND WHEREAS, the matter was placed in 288<sup>th</sup> Meeting held on February 15-16, 2018 of WRC and the Committee decided that "...Consequent to the issue of Revised Recognition order, Show Cause Notice was issued on 03.01.2017.

Institution in its reply has not submitted the staff list, Building Completion Certificate and additional FDR for Rs.4.00 lakhs

**Hence, Recognition is withdrawn from the academic session 2018-2019."**

AND WHEREAS, the Withdrawal Order issued on 28.02.2018. The institution filed a appeal to the appellate authority Hqrs. no. APPL12361 dated 06.04.2018. Regulatory file sent to Hqrs. on 26.04.2018.

AND WHEREAS, the appeal order dated 03.05.2018 the council hereby remands back the case of Annie Besant College, 47-48, Precanco Colony, Rajendra Nagar, Annapurna Road, Indore, Madhya Pradesh, to the WRC, NCTE for necessary action as indicated above.

AND WHEREAS, the matter was placed in 293<sup>rd</sup> Meeting held on June 12 - 14, 2018 of WRC and the Committee decided that "...The case file was seen. This is a case of appeal. The Appellate Authority vide order dated 03.05.2018 has remanded the case to WRC.

An examination of the staff file shows that the detail about the M.Ed. degree of the Principal is not given.

**Hence, Compliance should be submitted by the institution within one month."**

AND WHEREAS, the clarification letter issued on 29.06.2018 and reply of clarification received on 15.06.2018.


